To indicate significance, use the symbol “*” or “**” for $P < 0.05$ and $P < 0.01$, respectively, in the table and within the content of the article/manuscript. Utilize the metric system by using abbreviations such as 100%, 10 cm, 1 mg/mL, etc. If the mean and P-value need to be presented, the standard error of the mean (SEM) must be included.

In the Discussion part, this section may include the study’s findings, which should be supported by research comparisons with the results of others’ research. It should also address important issues or controversies in the subject matter and provide suggestions for further studies and potential applications.

The term “et al.” doesn’t need to be italicized. Use “and” when there are two authors. Use “et al.” when there are three or more authors. For example: David et al. (2008) and David and Thomas (2002)

In this article, references are cited in the text using the Vancouver citation style, which employs Arabic numerals in square brackets or superscript numbers according to the order of first appearance in the manuscript. Each reference is assigned a unique number and reused consistently throughout the text when cited again. For example, a single source is cited as [1], while multiple sources are cited as [2–4] or [5,6]. The reference list at the end of the article is arranged numerically, corresponding exactly to the order of citation in the text, and includes complete bibliographic information for each source. This citation format ensures clarity, conciseness, and consistency, and is widely adopted in scientific, engineering, and medical journals.
