

Terms and Conditions for Superapp B.V.

Effective Date: January 9, 2025

Welcome to the terms and conditions for Superapp B.V. ("Superapp," "we," "us," or "our"), the developer of the bondi app and website (collectively referred to as "bondi"). By accessing or using bondi, you agree to comply with and be bound by these terms. If you do not agree with these terms, please do not use our services.

1. Definitions

- User: Any individual who accesses or uses bondi.
- Services: The functionalities provided by bondi, including but not limited to finding friends, shared mobility vehicles, events, grocery delivery, item sharing, and navigation.

2. User Accounts

To access certain features of bondi, you must create a user account. By creating an account, you agree to:

- Provide accurate, current, and complete information during registration.
- Maintain the security of your password and account.
- Notify us immediately of any unauthorized use of your account or any other breach of security.
- Take responsibility for all activities that occur under your account.

3. Data Collection and Use

We collect personal data such as your phone number, name, and live location to provide our services effectively. By using bondi, you consent to the collection and use of your data in accordance with our Privacy Policy. This includes:

- Location Data: We may collect real-time location data to provide navigation and friend-finding features.
- Communication Data: We may collect data related to your interactions within the app (e.g., messages sent).
- Usage Data: We may collect information about how you use our services for analytics and improvement purposes.

We may share aggregated data with third parties for advertising and promotional purposes. However, this data will not personally identify you.

4. Service Availability

While we strive to provide uninterrupted access to bondi, we cannot guarantee that our services will always be available or error-free. We reserve the right to modify or discontinue any service at any time without notice. We are not liable for any interruptions or errors in service.

5. User Conduct

You agree to use bondi in compliance with all applicable laws and regulations. You further agree not to:

- Use bondi for any unlawful purpose or in violation of any local, state, national, or international law.
- Harass, threaten, or defame other users.
- Transmit any harmful or malicious software (e.g., viruses, worms).
- Attempt to gain unauthorized access to our systems or networks.
- Use bondi in a manner that could damage, disable, overburden, or impair our services.

6. Intellectual Property

All content within bondi, including text, graphics, logos, software, and other materials (collectively "Content"), is the property of Superapp B.V. or its licensors. You may not reproduce, distribute, modify, create derivative works of, publicly display, publicly perform, republish, download, store, or transmit any Content without prior written permission from us.

7. Third-Party Services

bondi may integrate with third-party services through APIs (Application Programming Interfaces). We do not control these third-party services and are not responsible for their content or practices. Your use of such services is subject to their respective terms and conditions. We encourage you to review the terms of service and privacy policies of any third-party services you use.

8. Limitation of Liability

To the fullest extent permitted by law:

- Superapp B.V., its affiliates, officers, directors, employees, agents, licensors, and service providers shall not be liable for any indirect, incidental, special, consequential damages arising out of your use of bondi.
- Our total liability to you for all claims arising out of or relating to these terms shall not exceed the amount paid by you for access to bondi in the twelve (12) months preceding the event giving rise to the claim.

9. Indemnification

You agree to indemnify and hold harmless Superapp B.V., its affiliates, officers, directors, employees, agents from any claims arising out of your use of bondi or violation of these terms.

10. Termination

We reserve the right to terminate or suspend your account at our discretion without notice if we believe that you have violated these terms or engaged in conduct that is harmful to other users or our interests.

11. Governing Law

These terms shall be governed by and construed in accordance with Dutch law. Any disputes arising from these terms shall be subject to the exclusive jurisdiction of the courts in Amsterdam.

12. Changes to Terms

We may update these terms from time to time at our discretion. We will notify you of any changes by posting the new terms on our website and app with a new effective date. Your continued use of bondi after changes are made constitutes your acceptance of the new terms.

13. Severability

If any provision of these terms is found invalid or unenforceable by a court of competent jurisdiction, such provision shall be limited or eliminated so that the remaining provisions shall remain in full force and effect.

14. Entire Agreement

These terms constitute the entire agreement between you and Superapp B.V. regarding your use of bondi and supersede all prior agreements and understandings.
