Avoid citing references in the abstract. Paraphrase rather than quoting. Use active rather than passive voice (but without personal pronouns). Abbreviations should be introduced at the first mention in the text.</p>

1. The introduction

This template is used to prepare research texts for submission to the Kirkuk University Journal of Administrative and Economic Sciences . Using **this template** will save time in review and production and will speed up publishing. However , using this template **is not** an application requirement. But you need to follow all the instructions provided here carefully. Do not modify the template in any way (delete spaces, modify font size/ line height, etc.). The research article should be written in English or Arabic , in 12 Times New Roman font , which includes the following: **Abstract** , Introduction , Theoretical framework or body of the research (Literature Review) , Objectives (Objectives) , research methodology , theory , examination _ Testing and analysis , results and discussion (Results and Discussion) , Conclusion (Conclusion) , acknowledgments (optional), and references . All references must be translated into English. The research text must be prepared using Microsoft Word .

2. Methodology

Should be titles The main body parts of the research paper should be written in font size 12, and only the first letters of the title words should be capitalized . It is necessary that there be a space of font size 12 above the paragraph title and font size 6 below the paragraph title . Sections should be numbered consecutively, and subsection titles should be in Times New Roman , font size 12, bold font type) (bold) with the first letters of the title words Just Big .


Moreover , Should Using the serial system in numbering addresses The numbering starts from the introduction, which will be assigned first: The numbering continues for the rest of the paragraphs according to their sequence, and if there are subparagraphs within the main paragraph, they are numbered depending on the paragraph number and its sequence number (for example, if there are subparagraphs within the introduction, the first will be numbered 1, the second 2, and so on. In the event that The presence of subparagraphs within paragraph 1 that take the sequence A, B, C, and so on. Write the addresses In Times New Roman font and bold. Note: The Acknowledgment paragraph is not numbered . The sources paragraph, which is written at the end of the research paper in Times New Roman font , bold, font size 12

3. Results and discussion

The results should be clear and easy to understand The results described should not be mentioned in the methods section The discussion of the results should address or explain what the results mean, and the discussion should be consistent with the results . This section is an example of **heading** formatting . And **the sub -headings** . The following subparagraphs show how to format figures, tables, and equations.

A. Tables and figures

Figures, tables, graphs and charts should be limited to the smallest possible number and can be in black and white with little misleading or in color with high clarity . Use color only if it is necessary for the correct interpretation of your shapes. Write the numbers and titles of the shapes in calligraphy Times New Roman , bold font size 10 (for example : **Figure 1**) The headings must be centered below the figure or picture. To illustrate these requirements, Figure 1 shows the figure formatting pattern in the Warth Scientific Journal paper. Moreover , There should be a space below the figure's title in font size 6, as well as at the top of the figure.



appearance 1 : The titles of the figures should be written at the bottom of the figure

In the case of tables, the same formatting requirements apply except that the table titles are placed at the top of the table and the table text is written in Times New Roman , Bold , font size 10. Table 1 shows the table formatting style.

Advise Often, some text is written directly after figures or tables.

b. Equations

Equations should be numbered consecutively with the equation numbers in parentheses . Use the equation editor to create the equation. It is necessary to ensure that the equation symbols are known before writing the equation or known immediately after the equation. Equation 1 and Equation 2 are the best examples to illustrate these instructions.

As mentioned previously, the equations must be numbered sequentially, and the serial number should be placed in parentheses on the right side of the text.

It is necessary that this part be brief and clear, and that it does not include any unknown names, titles, or excessive praise and compliments. Thank the funding agencies and parties that contributed to supporting the research, with the necessity of writing the names of the funding agencies in full.

Sources

This part is placed at the end of the research paper. The list of references and sources should only include published research papers Accepted by a publishing house known, in addition to adding a link (DOI) to the references and sources that are approved if available. Authors must also ensure the accuracy of All sources must be completed before submitting the research paper. The method of citing in the sources part is done using a citation method appropriate for the research and should be done using APA style . In addition, the list of sources should be written in handwriting .
