- The Public Affairs Society submitted an appeal to the Appeals Committee to support the funds needed to host two upcoming events focused on civic engagement and community service. The club's mission centers on promoting public policy awareness, advocacy, and social impact through student involvement. The additional funding will help cover the costs of their "Good Neighbor Event" in collaboration with the Bowery Mission, where students will curate care kits for the unhoused community, and their "Mental Health Letter Writing Event," which will include a guest speaker from the CUNY Graduate Center. These events aim to foster advocacy, mental health awareness, and community building among students.
