- Formal Complaint
 - TMHA along with Norman MHA, and Hockey MB received a complaint regarding the conduct of several association members during a community event. Concerns were raised around the Hockey MB social media policy, perceived disrespectfulness, insensitive actions and unsportsmanlike behaviour. This prompted an assembly of a Disciplinary Committee.

New Business:

- Body Checking
 - U15 and U18 are to keep body checking in house league divisions. No motion is required.

- U9 Tournament Budget
 - Budget was checked over by Judd, Nicholle and Tasha. All looks good.
- U9 Female Tournament in April
 - Will require a travel permit to attend and the tournament would have to be sanctioned. Alanna to follow up.
- U9 Goalies for Games/Tournaments
 - An inquiry was made to see if TMHA would loan out goalie gear to other association goalies at our U9 tournament if they did not have any. Yes we would be able to do this.
 - The Pas inquired about our ice surface size for U9 games. In the CA we use half ice and in the GB we use approx. $\frac{2}{3}$ ice surface due to it being a smaller ice surface until January.
- U18AAA Northstars Tickets

- o TMHA was given one set of season tickets for the U18AAA Northstars. Will can create a Nomination form on Facebook to have members nominate another member (player, coach, manager, official, volunteer) and there will be a random drawing for a ticket until all tickets have been gifted.
- Ad-Hoc for Policy 4.1
 - o The committee shall consist of 3 board members and 3 non board members. A post is to be shared on Facebook. Jessie will chair the committee and the members will be finalized at the next meeting.
- U13 House League
 - o Possible donation of house league jerseys. Colleen and Nicholle are working together on this.
- U11 Update/Coaching Shortage
 - o Recommended to have only 2 house league teams with 15 players per team instead of 3 teams of 10 players each. This resolves the coaching shortage as well as the goalies.
