Consent

By using Basketball 3 Pointers, you hereby consent to our Privacy Policy and agree to its terms.

Information we collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

How we use your information

We use the information we collect in various ways, including to:

- Provide, operate, maintain, improve, personalize, and expand our service
- Understand and analyze how you use our service
- Develop new products, services, features, and functionality
- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the service, and for marketing and promotional purposes.

Log Files, Cookies and Web Beacons

Basketball 3 Pointers follows the standard procedure of using log files. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the service, and gathering demographic information.

Like most other digital services, Basketball 3 Pointers uses 'cookies'. These cookies are used to store information including preferences and usage history. The information is used to optimize the users' experience by customizing the service based around individual usage patterns.

Google DoubleClick DART Cookie

Google is one of the third-party vendors on our service. It also uses cookies, known as DART cookies, to serve ads.
