Executive Director's Report: an overview of the current Association finances was presented. The September Financial Snap Shot was emailed and is in the SMAA Meeting Folder.

Current checking account balance is **\$177,774**. Total expenditures for 2024-2025 were \$179,623 (modest increase. Five 5)).

Two member schools have fully or partially paid their 2025-2026 SMAA Assessments **(48,583** Some other fees are still in the process of being collected.

Total expenditures for 2025-2026 currently are **\$9,753**, which is typically for the beginning of the year.
