# 'Advanced Accounting'!

### 1. Goals

The goal of this seminar is to equip participants with a thorough understanding of international accounting practices, particularly focusing on the International Financial Reporting Standards (IFRS). The seminar is structured to cover the foundational aspects of IFRS, beginning with the basics and extending to more complex selected topics. Participants will delve into central concepts, learning how to account for and assess various issues like intangible assets, property, plant and equipment, leases, and financial instruments. The course will also address advanced topics such as impairment testing, hedge accounting, pension provisions, and deferred taxes. The different topics will be introduced from a theoretical perspective, followed by a discussion based on a wide range of practical examples, especially highlighting management's room for judgments and estimates and how to read and interpret these in annual reports.

Additionally, the seminar will provide an examination of consolidated financial statements under IFRS, including the principles of domination, principal-agent relationships, and business combinations. Participants will gain practical insights through a case study of IFRS in BMW's financial statements.

By the end of the seminar, students will have a solid understanding of both the theoretical and practical aspects of IFRS, preparing them to navigate the complexities of international accounting and its implementation in a global business environment.
