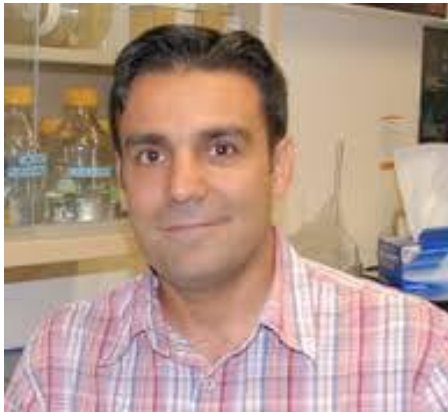
Joseph M. Derian, PT, DPT, OCS

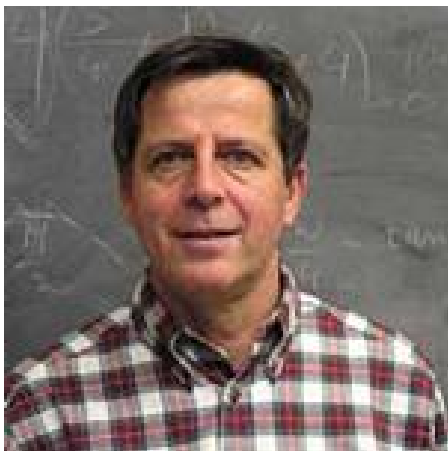
