


(I will say I'm mainly talking about the grooming allegations in terms of them lying, just for clarifications sake.)




GROOMING:




This screenshot is talking about Nate and a current member of the Thorne discord known as Allium, who is actually a minor:








The other minor he was in contact with was an ex mod named Tara (who is mentioned in the above message), she was able to somehow get into the 18+ server:











As you can see here, Nate assumed Tara was 18+ due to her being in that chat, once he found out her age, his messages became sparser and didn't engage. No, grooming involved, no nothing.


This person wasn't in the doc, but I want to put it here as more evidence of how Nate interacts with minors:












Is he being an asshole? Yep. Is he grooming anyone? No, bro doesn't even want a minor in his dms.

Nate is absolutely not a groomer, he's done what he needs to anytime he speaks with a minor. Such disgusting allegations that aren't true.

Like I said in my updated document, this screenshot is talking about another Mod by the name of Amber who isn't a minor. I got the age wrong in the other doc, she's actually 20 but still, she's an adult and was an adult during this vc chat. Nate was saying this to an adult.

She, Thorne and blckk have also gotten black out drunk in the minors VC, not to mention back when Nate was in thorne's server (before being banned) he and amber talked HEAVILY about sex in the minors VC

According to Nate, all this only happened on the 18+ channel in the discord or Thorne's private server.

Also, not sure if Thorne has a proper "minors vc", what they're talking about is general vc, something anyone can access, again, not sure if that's what the vc is actually called but if it isn't this seems like an attempt at making sound like they were drunk in a vc meant only for minors. Which is of course untrue.

Thorne instead of getting a proper therapist, talks to his old mods (who are minors btw) and also has a weird obsession with one of his older mods who would lie about his age (we theorize he's about 30-35) not to mention he brought him into the goddamn server, and he also doxxed a girl on the server

Ignoring the Thorne part, they try to claim that Nate is 30-35 as a way to make him seem creepier but Nate is only 21, the dude is young.





Edgy jokes, I was right, these are all edgy jokes. Unfortunately, when I looked back at the chat, I couldn't find any of these exchanges.








According to Nate, this is someone named 'Noodles', 'Mika' or 'Ayano' as she goes by now (she was also mentioned in the Allium messages I showed earlier).




I recognize this person as she also has personal dms with the mods I spoke to and I'm 90% sure she helped with the doc. However, take that with a grain of salt because I have no proof.




She is the one who was 'doxxed' by Nate finding her instagram, a public instagram Nate claims. Apparently, during their conversations, she would say things like "I bet you can't find x" or "I dare you to find x" and he would take this challenge seriously. So, that's how he ended up looking for the insta, however, he claims that he never spread around private info, only a public instagram account. As for the 'kept telling him not to follow her', I believe he said this wasn't true.

These are personal dms between the two and according to Nate, he can't get the original messages because Ayano edited most of her messages to be something completely different. You'll see in the screenshots almost every dm she sent has an 'edited' tied to it. However, this is impossible to prove as it could also be that she misspelled something and is OCD about it.

(One thing I want to say, do you see the sparkles in that last message? That's Max, if you saw the updated version of my other doc, then you know who this is. Just thought I'd mention that.)

So, first of all, Nate alleges that the whole "u want me so fucking bad" is because of Ayano (which is who they're talking about) that went unhinged and gave Nate a 21 second clip of a poem she wrote for him. Apparently, this girl really liked Nate but he wasn't interested so he told her no, but she kept pushing, due to her pushing he became more aggressive. That's how we got screenshots of this:




Here's the full convo:

That's all for this section, like I said, it's all "he said she said" so you guys can come to your own conclusions. I'm sure you all know what my opinion is lol.


