

## **Voting Process for the 26-27 Court Schedule**

The 26-27 Court Schedule has been proposed by the Scheduling Committee, approved by the Executive Board and approved by the Gold Canyon Park Management. It now goes before the GC Pickleball Club Membership for approval or rejection.

In an electronic Executive Board meeting with the sole purpose of voting on the 26-27 Court Schedule, a motion has been made by GC Pickleball Club President Don Oylear to place the proposed 26-27 Court Schedule before the general Gold Canyon Pickleball Club membership for approval or rejection. That motion was seconded by Scott Willms and approved by the GC Pickleball Club Executive Board.

A motion is now put before the Gold Canyon Pickleball General Membership by Don Oylear to begin the electronic voting process on March 9<sup>th</sup> for the Approval or Rejection of the proposed 26-27 Court Schedule.

Lori Irvine seconded the motion.

The voting process begins on March 9<sup>th</sup> in accordance with the Gold Canyon Pickleball Club (GCPC) By-Laws.

The GCPC By-Laws and the rules for electronic voting can be found on the club website.

The following is the process we will follow beginning with a Scheduling Committee Report.

### **2. 2026/27 Scheduling Committee Report**

Four Person Committee Representing All Levels of Play

Ann Mary Oylear, Board Member

- 2025-26 Committee did a great job anticipating the opening of the new Courts and scheduling players into Round Robin formats. Some of these plans worked well, some of them did not.
- We talked with past Board Members and several players in each category of play about what was working well and needs and ideas for change.
- We assumed the 25-26 schedule was running well. We focused on problem areas rather than to rebuild the entire Schedule.
- We identified that the combo High Intermediate/Intermediate time slot was messy and confusing.

- We collected research on which Round Robins were being filled, and which were not. We found that the Noon to 2 pm slots were not being used at all and that in some categories of play many of the second session Round Robins were not filled.
- We also acknowledged that the Novice players needed a Round Robin on the Mtn. Court schedule and some time allocated on the Main Court Schedule.
- The Committee feels confident that the few changes we have recommended will work well for the 26-27 Season with the knowledge that the Executive Board can still make minor tweaks up to 5% of the total schedule.
- The proposed Schedule was presented to the Executive Board and accepted.
- The proposed Schedule was presented to Gold Canyon RV Management and accepted.
- The Scheduling Committee volunteers dedicated time and energy to improve pickleball fun, and enjoyment for Gold Canyon Pickleball Club Members.

3. All GCPC members are invited to take part in a discussion of the motion for one week beginning March 9, 2026, through March 15, 2026, as stipulated in the GCPC By-Laws. The discussion will begin with a member submitting their view/discussion point on a form. Members can submit their discussion point **ON THIS FORM (Discussion now closed)**. Members can view other discussion points as well as any responses from the board [ON THIS SHEET](#).

4. At the end of the discussion week there will be three days of electronic voting as stipulated in the GCPC By-Laws beginning March 16, 2026, through March 18, 2026. Members can vote **ON THIS FORM (Voting now closed)**. **YOU MUST LOG IN TO VOTE TO ENSURE ONLY ONE VOTE PER MEMBER / PER EMAIL ADDRESS.**

5. The voting will be Yes or No. The majority of the vote will prevail.

6. If the Yes vote wins the majority of the vote the proposed 26-27 Courts Schedule is adopted and is implemented beginning September 2026. Up to 5% of total time on the Schedule may be amended.

7. If the No vote wins the majority the 25-26 Courts Schedule will remain in place for the 26-27 season. Up to 5% of the total time on the Schedule may be amended.

8. The Court Schedules for the 25-26 season and the proposed Court Schedules for the 26-27 season are available below for comparison.
