L. Decuir introduced Mr. Steven Nosacka via a phone call to the board to present what he could offer to help get the project up and running. S. Nosacka informed the committee that there were several ways to finance the capital project. S. Nosacka advised that there were a few steps that needed to b3 taken. 1. Determine a site for the project. 2. Select an architect. He advised he could offer assistance in getting the USDA loan pushed through and approved in about a 1 year time frame.

After this discussion, S. Judice motioned to recommend to the Board of Directors that we begin exploring the available land for purchase or trade along highway 90, with a second by K. Martin, with no objections.
