Questions submitted from stakeholders:

- 1. Can a facilitator run a multi-day retreat at a location other than a Healing Center? (i.e. at a retreat center or private home, given the facilitator owns the property or the property owner permits this use?)
- 2. Can a facilitator cultivate themselves and gift natural medicine to participants?

Can someone bring their personal use to a facilitator and, if so, what does that look like? Can they? What license is required?

Licensed Premises Information category:

• How should a licensed premises confirm that a participant is age 21 or older?

Regulated Natural Medicine category:

- What does the serving size of 10 mg of total psilocin mean? Is that the recommended dosage?
- Are packages of natural medicine products separated into individual serving sizes?
- How can I tell how potent a natural medicine product is? Is the percentage of psilocin in a product included on the label?

Personal Use category:

- Can I sell the natural medicine that I grow for personal use?
- Can I give the natural medicine I grow to others? Are there restrictions on when or how I can give it to someone else?
- What are some examples of the counseling, spiritual guidance, beneficial community-based use, supported use, or related services where I am allowed to share natural medicine grown for personal use?

I believe you plan to prioritise review of the applications. Do you have an estimate of how long each review will take?

Can micro cultivation operate in a private residence or does it have to be on un residential property?

Will cultivators be allowed to grow for healing centers at their private residences?

First off, is it even possible for an independent/contract grower to exist with the current regulations?

• If the above is possible, what would the application process look like and what would the required legal documents for the licenses be? Is/would there be a different fee than one for an owner/facilitator?

Testing - currently doing contract R&D - is that something we would be limiting if they became licensed?

Facilitator license - does DOR or DORA designate the license number?

Am I correct that a licensed facilitator in private practice (such as a therapist) will need both an owner license and a business license with DoR to work out of their existing mental health office and a facilitator license with DORA? Is the fee structure for licensing modified at all? I thought I heard something in your presentation today about only needing to pay the compliance fee for certain applicants? Can you clarify?

Will the licenses be public and available online? Yes - owner and business licenses will be available, not necessarily handler licenses

<u>Payment processing questions</u>: How is the Dept of Revenue allowing for processing payments of sale of the product? Are there any approved banks? Will there be in Federal restrictions to be aware of? Are there any guidances here?

Can you explain what each type of business is allowed to charge for? Ie: Cultivators can charge for natural meds themselves, Healing Centers can charge for services. Can they charge for products containing nat meds ie: teas/gummies, etc that they buy from another business?

Financial support for low-cost services to those seeking treatment - will the state provide a discount to facilitators serving under served communities/people?
