Content	The Constitutional Review course deals with the study of all forms and techniques of interpretation of constitutional norms. Constitutional review systems, the jurisdiction of constitutional courts, jurisprudential policies and a range of other important issues will be addressed in this case. Decisions of the constitutional courts of European and other countries, the constitutional court of the Republic of Kosovo and the European Court of Human Rights, are also the subject of this case.	
Purpose	This course aims to acquaint undergraduate students with the theoretical and practical part of the Constitutional Judiciary as a separate branch of law. In particular, students will analyze the basic concepts of the constitutional judiciary, systems and institutions of the constitutional judiciary. Special attention will be paid to the constitutional court of the Republic of Kosovo.	
Accessi bility	At the end of the course students will be able to:  Understand and recognize the basic legal institutions of the constitutional judiciary;  To know the design of the Constitutional Court system of the Republic of Kosovo;  To apply theoretical and practical knowledge acquired by the Constitutional Judiciary;  Be able to analyze the practical impact of the constitutional judiciary on the functioning and policy-making of states.
