What information I collect, use, and why

As an associate osteopath, I collect or use the following information to provide patient care, services, and other goods using the privacy policies of both clinics I work from. On occasion if you make contact me directly I collect or use the following:

- Name, address and contact details
- Gender
- Pronoun preferences
- Date of birth

- Health information (including medical conditions, allergies, medical requirements and medical history)
- Information about care needs (including disabilities, home conditions, medication and dietary requirements and general care provisions)
- Test results (including psychological evaluations, scans, bloods, x-rays, tissue tests and genetic tests)
- Payment details (including card or bank information for transfers and direct debits)

I also collect the following special category information to provide patient care, services, and other goods. This information is subject to additional protection due to its sensitive nature:

Health information

I collect or use the following personal information for information updates, marketing or market research purposes:

Lawful bases and data protection rights

You can request other information such as details about where I get personal information from and who I share personal information with. There are some exemptions which means you may not receive all the information you ask for. Read more about the right of access.

My lawful bases for collecting or using personal information to provide patient care, services, and other goods are:

 Consent - I have permission from you after I gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.

- Legal obligation I have to collect or use your information so I can comply
 with the law. All of your data protection rights may apply, except the right to
 erasure, the right to object and the right to data portability.
- Legitimate interests I'm collecting or using your information because it benefits you, our organisation or someone else, without causing an undue risk of harm to anyone. All of your data protection rights may apply, except the right to portability. Our legitimate interests are:
 - o As an Osteopath I will collect personal information from you to be able to advise on whether I can assist you or not. In most cases I will use the privacy policy of the individual clinic that you are a patient of. If you contact me directly through 'osteosmith' contact details I will collect the information to specifically refer you through to one of the clinics I work with if appropriate, or to another practitioner.

 Vital interests – collecting or using the information is needed when someone's physical or mental health or wellbeing is at urgent or serious risk. This includes an urgent need for life sustaining food, water, clothing or shelter. All of your data protection rights may apply, except the right to object and the right to portability.

How long I keep information

Patient records are kept by each clinic as per each individual clinic's retention policy which can be accessed through their websites.

Osteosmith (Karen Smith) website analytics data is retained for no longer than necessary, typically for a maximum of **26 months**, after which it is automatically deleted.

Duty of confidentiality

I am subject to a common law duty of confidentiality. However, there are circumstances where I will share relevant health and care information. These are where:

- you've provided me with your consent (I have taken it as implied to provide you with care, or you have given it explicitly for other uses);
- I have a legal requirement (including court orders) to collect, share or use the data;
- on a case-by-case basis, the public interest to collect, share and use the data overrides the public interest served by protecting the duty of confidentiality (for example sharing information with the police to support the detection or prevention of serious crime);
- If in England or Wales the requirements of The Health Service (Control of Patient Information) Regulations 2002 are satisfied; or
- If in Scotland I have the authority to share provided by the Chief Medical Officer for Scotland, the Chief Executive of NHS Scotland, the <u>Public Benefit</u> and <u>Privacy Panel for Health and Social Care</u> or other similar governance and scrutiny process.
