These Terms of Use (the "Terms") are an agreement between you and Nataliia Akunts (the "Developer", "we", "us") governing your use of the mobile application Аудиокниги и книги: читалка (Books & Audiobooks) (the "App") on iOS and Android. By downloading or using the App you agree to these Terms. If you do not agree, do not use the App.

1. The Service

The App provides access to a catalogue of audiobooks and e-books for personal, non-commercial streaming and reading, together with features such as a personal library, progress sync, bookmarks, reading goals, recommendations, and reviews. The catalogue may change over time; specific titles may be added or removed without notice.

2. Accounts

You can use the App as a guest or sign in with a supported account (such as Google). You are responsible for the activity that happens under your account and for keeping access to your device secure. You must be at least 13 years old (or the minimum age required in your jurisdiction) to use the App.

3. Subscriptions, Free Tier, and Payments

Premium subscription. The App offers auto-renewing subscriptions (for example weekly, monthly, or yearly) that remove ads, remove daily time limits, and unlock premium features. Prices and billing periods are shown in the App before purchase. Payment is charged to your Apple App Store or Google Play account. Subscriptions renew automatically unless you cancel at least 24 hours before the end of the current period. You can manage or cancel your subscription in your App Store or Google Play account settings; deleting the App does not cancel a subscription.

Free tier. Without a subscription, the App provides a limited amount of free listening and reading time per day and shows advertising, including optional rewarded ads that grant additional time.

Refunds. Purchases are processed by Apple and Google; refund requests are handled under their respective policies.

4. Content and Intellectual Property

All books, audio recordings, cover artwork, and other catalogue content are protected by copyright and are provided for streaming and in-app reading only. You may not copy, download outside the App's features, distribute, publicly perform, or make derivative works from the content, or circumvent any technical limitations of the App. The App itself, including its design and software, is the property of the Developer or its licensors. If you believe any content infringes your rights, contact us at nataakunts@gmail.com and we will review and, where appropriate, remove it.

5. User Content

You may submit content such as reviews. You retain ownership of what you write, and you grant the Developer a worldwide, royalty-free license to host, display, and moderate it within the App. You must not submit content that is unlawful, infringing, offensive, misleading, or spam. We may moderate, reject, or remove user content at our discretion.

6. Acceptable Use

You agree not to: use the App for any unlawful purpose; interfere with or disrupt the App or its servers; attempt to gain unauthorized access to accounts or systems; scrape, harvest, or bulk-download content or data; reverse engineer the App except where permitted by law; or resell or commercially exploit the App or its content.

7. Availability and Changes

We may modify, suspend, or discontinue any part of the App at any time, including the catalogue, features, free-tier limits, and subscription options. We will comply with applicable platform rules regarding active subscriptions if the service is discontinued.

8. Disclaimers

The App and its content are provided "as is" and "as available", without warranties of any kind, express or implied, including fitness for a particular purpose, accuracy, or uninterrupted availability.

9. Limitation of Liability

To the maximum extent permitted by law, the Developer is not liable for any indirect, incidental, special, consequential, or punitive damages, or for loss of data, arising from your use of the App. Our total liability for any claim relating to the App is limited to the amount you paid us in the 12 months before the claim arose. Nothing in these Terms excludes liability that cannot be excluded under applicable law.

10. Termination

You may stop using the App and delete your account at any time. We may suspend or terminate your access if you materially breach these Terms. Sections that by their nature should survive termination (including intellectual property, disclaimers, and limitation of liability) survive.

11. Platform Terms

Your use of the App is also subject to the applicable platform terms, including Apple's Licensed Application End User License Agreement and the Google Play Terms of Service. Apple and Google are not parties to these Terms and are not responsible for the App or its content; Apple is a third-party beneficiary of these Terms and may enforce them against you.

12. Changes to These Terms

We may update these Terms from time to time. The updated version will be posted at this URL with a new effective date; continued use of the App after changes take effect constitutes acceptance. Material changes may additionally be announced in the App.

13. Governing Law and Disputes

These Terms are governed by the laws applicable at the Developer's place of residence, without regard to conflict-of-law rules, except where the mandatory consumer-protection law of your country of residence applies. Disputes will be resolved in the competent courts of that jurisdiction unless applicable law gives you the right to another venue.
