ABSTRACT [Centered, Times New Roman 11 pt, Bold, Single]

Initiate with a brief introduction. State the objective specifically and clearly, as to what is to be obtained. Give a brief account of the methods. State results briefly. State conclusions or recommendations and link this to the significance of the work. The abstract must be integrated and independent, which consists of an introduction and purpose, methods, results, conclusion, and suggestion. The abstract must be written within 250 words maximum in one paragraph which has **no reference** and accompanied keywords. [Times New Roman 10 pt, Single]

Keywords: Keywords should not be more than 5, avoid the words in the title. The keyword must represent the content of your article. Use British or American spelling (not a mixture of these), and avoid general and plural terms and multiple concepts (for example, "and" and "of"). Write in italic only for foreign words (not English). It should be written in alphabetical order. [Times New Roman 10 pt, Single]

INTRODUCTION [Times New Roman 12 pt, Bold, 1.5 space]

Present brief and clear information concerning the research's background, aim, and purpose. Provide the background information regarding your study and why you are interested in the study. The introduction must present the details of the research problem. Please ensure that the introduction section provides well-balanced, current, and relevant citations. Please justify the research problem with sufficient and relevant citations. Avoid/minimize citing old references (more than 10 years old), but cite the first finding that relates to your research although it is more than 10 years old. The introduction should end with presenting the gap of current related knowledge, then the purpose of your research to answer your research question. [Times New Roman 11 pt, 1.5 space]

METHOD [Times New Roman 12 pt, Bold, 1.5 space]

It should mention the time and place of research in the first part. All materials and methods that used such chemicals for analysis, treatment, and experimental design must be stated clearly and briefly. Write what you did in the past tense. If you did a new method, describe very clearly step by step so another researcher can reproduce your method. But if you employ an established method, explain

briefly and clearly write the reference you cited so another researcher can find out more detail information regarding the method. All the parameters and statistical methods must be written apparently. Materials and methods must be written using 400 to 600 words. [Times New Roman 11 pt, 1.5 space]

RESULT AND DISCUSSION [Times New Roman 12 pt, Bold, 1.5 space]

This section is the most important part of your manuscript. Initiate the Discussion with the answer to your objective, which is the main finding. Discuss your data comprehensively by linking the data to each other to support your main finding; hence, do not separate this section into sub-sections. Support the mechanism of your main finding with the interpretation of related data comprehensively, as well as relevant citations. Overall, the discussion must be the interpretation of your results, and comparison with other studies to convince your data if they are consistent. But if you find a work which is in disagreement with yours, you must confront it to convince the reader that your data is correct or better. Explaining the weakness or limitation of your study may improve your manuscript quality by showing the readers that you have an in-depth understanding of your research and thinking objectively.

Finally, emphasize your main finding, what is new and why it is important, and suggest future studies that need to be carried out. Results should present the findings of your research in logical order. Present from the most important to least important of your data, with a clear story and make it easy to understand. The results obtained from the research have to be supported by sufficient data. The research results and the discovery must be the answers, or the research hypothesis stated previously in the introduction part. [Times New Roman 11 pt, 1.5 space]

CONCLUSION [Times New Roman 12 pt, Bold, 1.5 space]

Clearly answer your research objective in the Conclusion. Write your conclusion clearly so the reviewers and the readers can easily judge the merits of your work. Do not include the statistical statement in this section. You can also suggest future experiments based on your conclusion. The conclusion must be written in less than 150 words and in one paragraph. [Times New Roman 11 pt, 1.5 space]

Figure and Table

Figures and tables must be placed separately from the main text. All figures should be presented in black and white, with captions provided below each figure. A space must be included between the figure and its caption. The title of the figure or table should appear directly after the caption, formatted in 10pt font size, single-spaced, and centered. Authors are required to refer to each figure or table explicitly in the text using phrases such as "In Table 1..." or "Figure 2..." to ensure clarity. All figures must be submitted in high resolution to avoid blurriness or pixelation.




Figure 1. Illustration of figure width same as column width




Figure 2. Illustration of figure's width twice of column width

In this part, all the used references must be taken from primary sources (scientific journals and the least number is 80% from all the references) that were published in the last ten years. Each article should have at least ten references.
