Dear Parent or Guardian:

We are pleased to inform you that once again the Adams-Friendship Area School District is participating in the Community Eligibility Provision (CEP), while participating in the National School Lunch and Breakfast Programs for the entirety of the 2025-26 school year. All enrolled students can receive a healthy breakfast and lunch, at school, free of charge each day of the school year. The district will still be requesting household applications although they are not required to receive the free meals, simplified applications will be distributed by the school to collect household income data for other benefits, listed below.

Completing the alternate household application is necessary for the district to secure benefits for other programs, including the Title Programs, AGR (Formerly SAGE), Federal Funding and may also be used to determine if your household is eligible for additional benefits, such as the Summer EBT program and no fees charged for field trips and athletics.

Along with the above-mentioned meals provided at school, students at the high school have the option to purchase additional food items as a'la carte. We also offer a no cost meal after school at the high school free of charge and will again be participating in the FFVP grant at the elementary school handing out a fresh fruit or vegetable 2 days per week.
