DIVISION COMMANDER: DCDR Bob Cody:

- -District quiet for last 6 weeks.
- -Questioned who will go to the election meeting of each Flotilla to observe and validate.
- -Walter Roberts reported to him that 74 has no candidates for FC and VFC. No waiver has been requested.

DIVISION VICE COMMANDER: VCDR Mike O'Connor:

- -District quiet.
- -An email sent in his name this day was something hacked, not sent by him.
- -The 41 is still operating for members who need hours.
- -Thursday patrols, with CG for CG training.

- -Patrols Sundays, for member training.
- -He will propose in January or February that District policy be modified to allow an active Coast Guard member to act as a QE. This has been successful in other districts. Current policy is for October to be held for QEs only for new Boat Crew, this needs to be changed to allow renewals.
- -Consistency is needed for forms and inspections of facilities.
- -Consistency needed among District staff.
- -Short of PLBs, shortage not happening in other Districts.
- -Processing very slow.
- -Plan to send resolution to District in January / February to make changes.

Member Comments: Shortage of Coxn's and Boat Crew. Only 4 QEs in the District, plus one at Station. Lakin suggested that if members (in 2022) had 50 or more boat crew/coxswain hours, could Mike O'Connor send up the chain a suggestion that REYR is waived in 2023, until QE session is completed. If we are in REYR, there is an additional requirement of 12 hours on-water before you can even get a QE session. This additional 12 hours requirement would be waived if we are not in REYR.
