

Why Regenerative – Ticket Terms & Conditions

Last Updated: January 1, 2026

By purchasing a ticket to any Why Regenerative event (“Event”), you agree to the following Terms & Conditions.

1. Ticket Purchases & Payment

All tickets must be paid in full at the time of purchase to secure admission.

Why Regenerative reserves the right to refuse or cancel any order at its discretion, including in cases of suspected fraud or unauthorized resale.

2. Refund Policy

Tickets are eligible for refunds under the following conditions:

- **Full Refund:** Available for cancellations made **six (6) weeks or more prior to the Event start date**
- **50% Refund:** Available for cancellations made **between six (6) weeks and three (3) weeks prior to the Event start date**
- **No Refunds:** Cancellations made **within three (3) weeks of the Event start date** are not eligible for a refund

All refund requests must be submitted in writing to info@whyregenerative.com.

Refunds, when applicable, will be processed to the original payment method within a reasonable timeframe.

Exception: If the Event is canceled by Why Regenerative, ticket holders will receive a full refund or the option to transfer their ticket to a future event.

3. Ticket Transfers

Tickets may be transferred to another individual up to **5 days prior to the Event**, provided:

- The request is submitted via email to info@whyregenerative.com

- The new attendee's full information is provided

Why Regenerative is not responsible for unauthorized transfers or third-party resale.

4. Event Changes & Program Modifications

Why Regenerative reserves the right to modify the Event's schedule, speakers, location, or format at any time.

Such changes do not entitle ticket holders to a refund unless the Event is fully canceled.

5. Force Majeure

Why Regenerative shall not be held liable for delays or cancellations due to circumstances beyond its control, including but not limited to natural disasters, public health emergencies, government restrictions, labor disputes, or venue issues.

In such cases, Why Regenerative may reschedule the Event or offer credits at its discretion.

6. Admission & Conduct

Why Regenerative reserves the right to refuse admission or remove any attendee who engages in disruptive, unsafe, illegal, or inappropriate behavior.

No refunds will be issued in such cases.

7. Media Release

By attending the Event, you grant Why Regenerative permission to use your image, likeness, and voice in photographs, video recordings, and promotional materials without compensation.

8. Assumption of Risk

Attendees voluntarily assume all risks related to participation, including personal injury, property damage, or loss.

Why Regenerative is not liable except where required by law.

9. Food & Beverage

Attendees are responsible for managing their own dietary restrictions and consumption.

Why Regenerative is not liable for allergic reactions or food-related issues.

10. Intellectual Property

All Event content remains the intellectual property of Why Regenerative and its speakers.

Recording, reproduction, or distribution without prior written consent is prohibited.

11. Data & Privacy

By purchasing a ticket, you agree to receive Event-related communications.

Your data will not be sold and will be handled in accordance with applicable laws.

12. Limitation of Liability

To the fullest extent permitted by law, Why Regenerative's liability is limited to the amount paid for the ticket.

These Terms shall be governed by the laws of the State of New York.
