



Maker's Market Vendors Agreement

1. By signing and paying the booth fee, you accept and will follow the rules of this contract and the Market Rules and Policies available online and in print. Fees are \$25 per booth per event for maker booths.
2. A contract **MUST** be filled out and signed by the person or persons operating the booth during Market hours. Contracts and payment (payable by cash, check or card) must be payable to Clovis MainStreet non-profit a minimum of one day prior to the day of the event. All payments are non-refundable, credit will not be given for no-shows as funding is used for marketing efforts, event resources and management.
3. The Eligibility and Requirements set out in the attached Market Rules and Policies must be followed.
 - a. Sellers must provide their own booth set up; tent, tables, chairs and displays.
 - b. Seller is responsible for collecting any applicable sales tax.
 - c. Sellers must meet all city and state business permitting or licensing required for their business type or products.
4. Booth Assignments; Booths will be assigned by the event organizer and done on a first come basis and filled in order to avoid vacant spaces. Consideration may be given to the type of products you are exhibiting.
