### **Comments Made and Questions Raised During Discussion**

There were a number of comments made and questions raised during the discussion following the Post-it Note™ exercise. What follows are some of those comments and questions as they appear in my notes. These are certainly not a complete summary of the discussion.

- Quiet agent of change.
- We need to make sure we recruit the right people to have at the table.
- Every meeting needs to have a celebration of successes segment
- Should the members meet less frequently? (This grew out of a discussion about lack of engagement by some of the members).
- Do we have the right size for the group?
- Who is/should be at the table?
- One Lenawee seems to be “collaboration project” based.
- There is a challenge with collaboration between governmental entities.
- We need to foster synergy rather than competition for money.
- Would it make sense for One Lenawee to come under the umbrella of the Lenawee Community Foundation? (This question lead to some discussion about the potential for synergy between the two groups.

1. Craft something in the nature of a Case Statement relative to One Lenawee coming under the umbrella of the Lenawee Community Foundation.
2. Discuss this idea with the larger One Lenawee Group.
3. Have a meeting with Dave Hickman to discuss the idea.
