RE: Update Report "Public Uses for Public Lands at the Celery Fields"

Date: July 11, 2018

This is to introduce the Update Report requested by the Board after Fresh Start's presentation of viable options for two public parcels at Apex Road and Palmer Boulevard on April 25, 2018. The Board directed that we take this time to refine our results, which have been distilled into this report, entitled "Public Uses for Public Lands at the Celery Fields."

We appreciate the time and attention your staff has provided over the past seven months. Our two prior reports on Feb. 5 and April 25, 2018, detail the meetings, outreach, advisory panel input, surveys and professionally guided roundtable process that led to four proposals. This report focuses on the YMCA proposal. The Y has done a site analysis of the Quad site, and finds an ample market of potential users. Fresh Start's own survey of its HOAs found a substantial need for athletic facilities -- one that will only grow with the growth coming to East County.

We understand that it was not possible to schedule a presentation of our additional findings to the Board prior to the July-August break. The break will provide time to review this new material along with a complete set of our earlier reports. If anything else is desired, let us know.

In brief, we ask that the Board put the public back in our Public Lands. The possibilities for a small, community-oriented facility offering healthy opportunities for exercise, sports, and learning for people of all ages at this site are remarkable. A YMCA near the Celery Fields and Audubon's' nature center will foster synergies that go well beyond the ordinary:

At the Celery Fields, the Sarasota Y could offer a rich array of children's programs making great use of the natural treasures right next door. Think of kids birding with Audubon volunteers, and fishing, hiking, and kayaking with YMCA leaders. A YMCA at the Celery Fields would amplify the range and richness of what our community's seniors and children can experience.

Jane, as head of long range planning, you better than anyone are aware that new developments underway in East County will create a new population that will need of public facilities, open spaces, roads and services. Selling the people's lands to private developers will not fill a lack that future residents will demand, necessitating future land purchases and plans. Our signatories opposed two such sales last year. The County can and must do more to anticipate the impacts, needs, and best options for coming future growth. It's coming fast. As our report states:

We take this opportunity to assert the public's right to a vision that balances private development with public needs.

This is a once-in-a-lifetime opportunity to create something special for an exceptional area and its people. With our thanks, we stand ready to work with you.
