The Climb Tour - Entrepreneurship Edition: The Climb Tour provides a transformative career immersion experience designed to empower young individuals by exposing them to a diverse range of career opportunities. Participants engage in leadership training, personal development, career exploration, and an entrepreneurship incubator program. In the incubator, they'll learn how to create and launch their own business or nonprofit and pitch their ideas to a panel of judges and companies for the chance to win valuable incentives. The program also includes a site visit to leading companies, providing participants with a firsthand look at various industries.

Program Criteria

^{**}All selected participants are required to follow our organization's rules and regulations, including but not limited to Covid-19 and mask policies.

^{*}All selected participants are required to attend all virtual programming and the live tour.

Failure to attend all virtual programming and the live tour will result in paying a \$500.00 cancellation/termination fee.

(Scheduling conflicts will be addressed on a case-by-case basis)

- 1) Open to candidates residing or attending school in New Jersey, Pennsylvania, Delaware, and New York
- 2) Must have transportation to the bus stop or meeting stop for The Climb Tour site visit
- 3) Bus Stop: TBD
- 4) Participants who cannot get to the bus stop must provide their own transportation to New York City, where we will all meet.
- 5) We will provide a school note for any student who is currently in school.

To apply, candidates must:

- Be a middle school student: (6th 8th grade): * We are accepting a limited number of middle school students. If you would like to recommend a middle school student, please email us before applying.
- Be a high school student: (9th 12th grade): Any student currently enrolled in high school.
- Be an undergraduate student: Any student currently enrolled in a two-year or four-year college/university.
- Be a graduate or law student: Any student currently enrolled in a graduate or law program.
- Be a recent graduate: Any person who graduated from an undergraduate, a trade school, or an apprenticeship program in 2023 or after
- Be a non-traditional student: A nontraditional student is anyone who wants to attend
 college in a format or time frame that differs from the typical route. A nontraditional
 student must have a GED or high school diploma. This includes any student who is
 currently enrolled in a trade school, an apprenticeship program, or taking a gap year.

Candidates must answer the following prompt:

As part of the Climb Tour program, you will have the opportunity to develop and pitch your own business or social impact venture. Please describe any ideas you have for a venture you would like to create. If you do not have a specific idea yet, share your passions and the issues that inspire you, and explain how these motivations might influence you as an entrepreneur.

Program Timeline

The program will take place virtually, with the exception of The Climb Tour in New York City. Students are expected to participate in at least 90% of our online workshops and events. If a scheduling conflict arises, students must inform us either during the interview process or at the start of the program. How will I get there?

YesSheCanCampaign will provide free bus transportation to New York for participants living in the Burlington County and Mercer County area. Students must arrange their own transportation to and from New York City if they do not live near our bus stops.
