Please follow the APA Style to site the previous studies, books, or news (Mubarak, 2019). (Times new roman, 1.15 line space, 12 pt, justify)

In this section, you may want to divide into several sub-points, such as (1) research design; (2) participant; (3) research procedure; (4) instrument; (5) data analysis, etc. (Times new roman, 1.15 line space, 12 pt, justify)

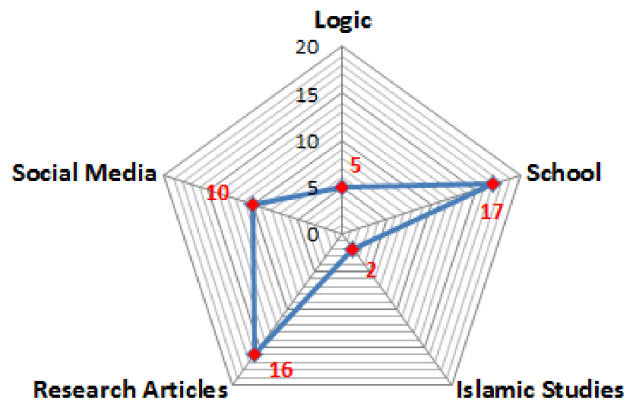
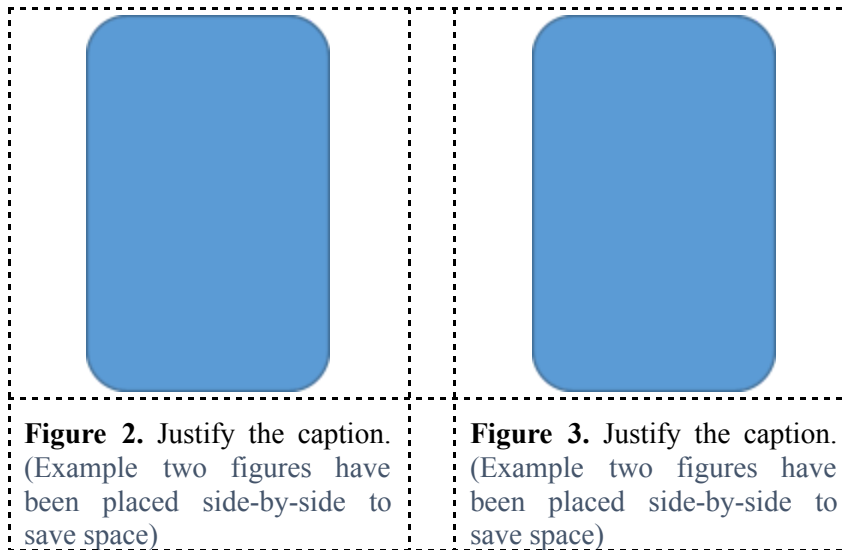


Figure 1. Put the image and information in the middle (11pt)

DISCUSSION (Capital, bold, 12pt)

CONCLUSION (Capital, bold, 12pt)

Conclusions should be the best points of your paper. The conclusion should: (1) stress the importance of the researcher's statement, (2) give the essay a sense of completeness, (3) answer the research questions or research purposes, and (4) leave a final impression on the reader and suggestion for further study. (Times new roman, 1.15 line space, 12 pt, justify)

ACKNOWLEDGEMENTS (optional)

Acknowledgments of people, grants, funds, etc., should be placed in a separate section not numbered at the very end of the paper. (Times new roman, 1.15 line space, 12 pt, justify)

REFERENCES (APA style, 8th Ed.)

In this journal used APA style, 8th edition for references. There should be a reference article published in a reputed international journal (indexed Scopus or WoS). It needs 70% of references from articles (last 10 years) and 30% of references from books.
