

# Terms and Conditions

Otherwise, permission is granted to Holistic Tikun to perpetual, royalty-free, worldwide, irrevocable license to use such images for publicity and promotional purposes.

No responsibility is accepted for losses, expenses due to delays, changes in flights or other services because of strikes, accidents, sickness, damage, negligence, weather, war, changes in schedules, or other similar causes. Holistic Tikun and its partners do not assume responsibility for accidents or deaths that can be traced to the participant's

negligence, acts of third parties, or exterior circumstances such as weather, natural occurrences, war, or other similar causes.

## **CANCELLATION**

**Cancellation by Holistic Tikun.** Without limiting any of the other rights of Holistic Tikun herein, Holistic Tikun reserves the right to terminate or cancel any Experience (including as the Experience is occurring) if Holistic Tikun finds, in its sole discretion, (i) that a Participant is violating applicable law or this Agreement, (ii) that the conduct of a Participant may be objectionable or harmful to other Participants, or (iii) to comply with a court order. If Holistic Tikun cancels an Experience pursuant to this section, then notwithstanding any other provisions of the Cancellation and Refund Policy, the Buyer will (unless the Experience is canceled due to the conduct of a Buyer or Attendee) be issued a refund, and the Host will not be entitled to any Deposits or Experience Fees. If the Experience is canceled by Holistic Tikun due to no fault of the Host, the Host shall still be entitled to payment for the Experience.

- and 100% refund if canceled 59-

Neither Holistic Tikun nor any carrier is liable for independent contractors.

## **EVACUATION PROCEDURES AND COSTS**

Holistic Tikun Retreat Leaders, local guides, or other representatives' decisions will at all times be final on all matters likely to affect the safety and well-being of the trip. We reserve the right to prohibit any traveler from continuing a trip with no right of refund if, in our opinion, that traveler's actions pose a threat to the safety of others, to the wildlife, themselves, or if the traveler's actions and/or behaviors are harming the enjoyment of the trip for others.

Evacuation costs are to be covered by the person being evacuated.

## **BEHAVIOUR**

We reserve the right to ask participants to leave the retreat if their behavior is disruptive to the running of the retreat to other participants or staff. If you withdraw from the retreat at any time or if you are requested to leave due to disruptive behavior, no part of the retreat fee shall be refunded. In the case of our decision to ask you to leave, all matters arising from a dispute are subject to Mexican law and are subject to the jurisdiction of the Mexican courts.

## **SMOKING, DRUGS, ALCOHOL, AND RELATIONSHIPS**

Drinking alcohol is prohibited, and smoking is discouraged and is allowed only in the Designated area. Use of drugs and/or excessive drinking of alcohol on Centre property is cause for immediate expulsion

Except as otherwise provided herein, the Parties may litigate in court to compel arbitration, stay proceedings pending arbitration, or confirm, modify, vacate, or enter judgment on the award entered by the arbitrator.

If, for any reason, the Dispute proceeds in court rather than arbitration, the Dispute shall be commenced or prosecuted in the state and federal courts located in Mexico, and the Parties hereby consent to and waive all defenses of lack of personal jurisdiction and forum non-convenient with respect to venue and jurisdiction in such state and federal courts.

In no event shall any Dispute brought by either party related in any way to the site be commenced more than one (1) year after the cause of action arose. If this provision is found to be illegal or unenforceable, then neither party will elect to arbitrate any Dispute falling within that portion of this provision found to be illegal or unenforceable, and such Dispute shall be decided by a court of competent jurisdiction within the courts listed for jurisdiction above, and the Parties agree to submit to the personal jurisdiction of that court.
