Privacy Policy for Secure VPN

This Privacy Policy outlines the practices and policies implemented in the app "Secure VPN" developed by CapraDev. regarding the collection, use, and disclosure of personal information from users of the App.

1. Information We Collect

- **Personal Information**: We may collect certain personal information that you provide directly to us, such as your name, email address, or payment information when you make an in-app purchase.
- **Non-Personal Information**: We may automatically collect non-personal information from your device, including but not limited to your device type, operating system, unique device identifiers, IP address, and usage data related to the App.

2. Use of Information

- Advertisements: Advertisements displayed within the App may be tailored to your interests based on the non-personal information collected. However, we do not share your personal information with advertisers without your explicit consent.

3. Disclosure of Information

- Third-Party Service Providers: We may engage third-party service providers to assist us in operating and maintaining the App or to perform certain services on our behalf. These service providers may have access to personal information for the sole purpose of performing their functions but are obligated not to disclose or use it for any other purpose.
- Legal Requirements: We may disclose personal information if required to do so by law or in response to a valid legal request from law enforcement authorities, courts, or government agencies.

4. Data Security

We take reasonable measures to protect the security of the personal information provided to us. However, please note that no method of transmission or storage is completely secure, and we cannot guarantee the absolute security of your information.

5. In-App Purchases

When you make an in-app purchase, your payment information may be collected and processed by the relevant app store or payment service provider. We do not collect or store your payment information. Please refer to the privacy policies of the respective app stores and payment service providers for more information.

6. Children's Privacy

The App is not intended for use by individuals under the age of 13. We do not knowingly collect personal information from children under 13. If we become aware that we have collected personal information from a child under 13, we will take steps to delete it promptly. If you believe that we may have collected personal information from a child under 13, please contact us using the information provided at the end of this Privacy Policy.

7. Data Deletion

When a user decides to uninstall the app from their device, all the data associated with the app, including any user-specific data, will be automatically deleted. This means that any information or personal data that was stored within the app will be permanently removed from the device. The app ensures that no traces of the user's information remain on the device. This practice promotes user privacy and security, as it minimises the risk of any unauthorised access or misuse of personal data after the app is removed.
