These rich landscapes support all five species of Pacific salmon, three of North America's largest caribou herds, abundant moose populations, and vast numbers of migratory birds.

Right now, BLM wants your input on whether to maintain long-standing protections for these public lands. That means you have a chance to stand up to protect fishing and hunting opportunities.

A "midnight decision" by the Trump Administration **threatened to repurpose these lands for extractive industrial development.** But now, we have a chance to stand up for our public lands.
