

## Privacy Policy for Arrow Out Match

Welcome to Arrow Out Match! We value your privacy and are committed to protecting your personal information. This Privacy Policy explains how we collect, use, store, and share your information, as well as the rights you have regarding your data. 1. Information We Collect We only collect information necessary to provide and improve the game experience:

- Game Data: To save your progress, we store data locally on your device, such as level progress, scores, and settings preferences.
- Log Information: If the game crashes or experiences issues, we may collect anonymized crash logs and performance data to diagnose and fix problems.
- Third-Party Service Information: If the game integrates third-party services (e.g., advertising or analytics platforms), those providers may collect information under their own privacy policies. See Section 4 below.

1. How We Use Information We use the collected information for the following purposes:

- To provide, maintain, and improve the core gameplay experience of Arrow Out Match.
- To save your personal game progress and settings.
- To analyze anonymized aggregate data to understand overall user behavior and optimize game design and content.
- To diagnose technical issues and ensure service security and stability.
- To comply with legal obligations, audits, or security requirements when necessary.

2. Data Storage and Security

- Your primary game progress data is stored locally on your device. Clearing the app data may result in progress loss.
- We implement reasonable technical and organizational measures to protect your information from unauthorized access, disclosure, alteration, or destruction.
- We retain your information only for as long as necessary to fulfill the purposes outlined in this policy.

3. Third-Party Services Our game may include links or code from third-party service providers, such as:

- Advertising Services: To display personalized or non-personalized ads. Advertisers may collect device identifiers to deliver relevant advertisements.
- Analytics Services: Such as Google Analytics for Firebase, to analyze anonymized usage patterns.
- App Stores: Such as Google Play Store, to process in-app purchases.

These third-party services have their own privacy policies. We encourage you to review their policies to understand how they handle your data. We are not responsible for the practices of third parties. 5. Your Rights Depending on your jurisdiction, you may have the following rights regarding your personal information:

- Access, correct, or request deletion of your personal information held by us.
- Restrict or object to the processing of your information.
- Data portability.
- Withdraw consent (where processing is based on consent).
