I want to address a comment I made earlier today and apologize. I was trying to convey that we need more support for our youth. But the fact is that what I said and the way I said it was not appropriate and I wrongly singled out Somali youth. I recognize and acknowledge the hurt and anger my statement caused. I am sorry.

I look forward to meeting with community members and continuing our shared work to make Minneapolis a safer city for everyone.

10:21 PM – Council Members Jamal Osman (Ward 6), Jeremiah Ellison (Ward 5), and Aisha Chughtai (Ward 10) issue a joint statement condemning CM Rainville's comments, calling for a public apology and a meeting with the community regarding his comments, and suggesting that council members will work to take "formal actions at our disposal – whether it be ethics complaints, censure, or something else" to hold CM Rainville accountable.

Earlier today, our colleague Michael Rainville, the Council Member representing Ward 3 (Northeast, Southeast, and Downtown Minneapolis), held a community event through his Council Office to discuss public safety. When discussing the uptick in crime over the 4th of July weekend, he made incorrect, inappropriate, and disturbing comments stating that Somali youth overwhelmingly perpetrated crime.

Council Member Rainville's statements are dangerous and promote the over criminalization of Somali and Muslim communities. He added that he would visit a mosque in Northeast Minneapolis to tell leaders and elders "their children can no longer have that kind of behavior." However, none of the suspects from this weekend are from Council Member Rainville's Ward, the 1st Police Precinct (Downtown), or the 2nd Police Precinct (Northeast). Multiple are not from Minneapolis.

Throughout the day, we've spent time connecting with residents, elders, leaders, and youth in the Muslim community. We share in the hurt they've expressed to us, and we're committed to ensuring our community isn't targeted. Council Member Rainville perpetuated hurtful stereotypes which have historically been used to rationalize law enforcement action targeting our already over-policed communities.

We urge Council Member Rainville to:

- Make a formal statement apologizing to the Somali community for making Islamophobic and racist comments
- Hold a public community meeting to allow any member of the community to come and share how his comments have affected them.

This is one of the holiest weekends in Islam. Eid Al-Adha is an important celebration for all Muslim communities. When we return from the holiday, we will work with our Council colleagues to take the formal actions at our disposal—whether it be ethics complaints, censure, or something else—to ensure CM Rainville is held accountable for the harm he has caused.

We're looking forward to spending the weekend connecting with our family and our community.

The Somali Student Association of the University of Minnesota strongly condemns the comments expressed by Council Member Rainville against our Somali and Muslim communities. As an elected official representing the public, there are greater expectations placed not only on your actions but also on the consequences of your words. The comments expressed by Council member Rainvile were not only hurtful but disrespectful. He chose to single out the Somali community as a whole for the despicable behaviors that took place over the 4th of July. But went further stating that he would come to our community center and chastise our elders. This is not how public safety is achieved. This is a continuation of time-tested and failed methods of addressing public safety. These comments do nothing in the way to make our communities safe, but create a scapegoat and build on stereotypes that lead to over-policing and dehumanization. Our city and our nation have tried time and time again to address public safety through failed policies such as broken-window, more officers, and stiffer sentencing. None of these policies achieved their stated goals, they have only divided us further and weakened our communities. To address public safety we need to take a holistic approach and engage in change from the bottom-up and top-down. That means leaders and community members holding each other accountable. I'd like to take this opportunity to update you on my response to the comments made by Council Member Michael Rainville - the comments which furthered a false narrative, a racist stereotype.

Over the weekend, I took time to connect with my fellow Council Members, City Staff, as well as Ward 11 community members – the purpose of these conversations was to check-in, provide a safe space, and let them know that I am here to support them.

I too encourage Council Member Michael Rainville to take the necessary steps to hold himself accountable for the comments he made, and I stand by my fellow Council Members who have asked for him to make a formal statement and hold a public meeting.

I want to thank my fellow Council Members who called out this racist stereotype – because if left unchallenged these racist stereotypes often lead to microaggressions, discriminatory behavior, etc.

It is all our responsibilities to educate ourselves, and breakdown these racist stereotypes.

As a part of the 2022 Budget, the former City Council approved \$30,000 in funding for professional development for Council Members – I will be exploring using a portion of these funds to have an Anti-Racist Coaching Opportunity for Council Members. An Anti-Racist Coaching Opportunity will not change what has happened – but it will hopefully provide us with an opportunity to educate ourselves and prevent this from happening again.

To all my Ward 11 Community Members, I want to remind you, I host Weekly Office Hours every Wednesday from 10:00 AM-12:00 PM, and it is a safe space, I am here to connect with you – and support you.

Overview and rationale:

On Friday July 8, 2022, Council Member Michael Rainville made comments targeting Somali and Muslim communities regarding public safety.

Resolved:

SD60 DFL stands with the Minneapolis DFL in condemning Council Member Michael Rainville's dangerous and hurtful remarks.

We too state loudly that "Racism has no place in Minneapolis." No one is safe when we root public policy decisions in fear.

As we believe support for Minneapolis youth should be rooted in community, care, and restorative practices, we call on CM Rainville to repair the harm he caused and to seek restorative reconciliation (for example: meet with Edison High School Student Council and hear directly from them what supports they need).

We remind CM Rainville that an apology requires more than words; sustained and corrective actions are required (for example: hold a public community meeting to learn how his comments affected them).

Senators Kari Dziedzic and Bobby Joe Champion (both DFL-Minneapolis) released the following statement today in response to Minneapolis City Council member Michael Rainville's harmful comments at Friday's Ward 3 community meeting.

"We represent Minneapolis in the Minnesota State Senate and we strongly condemn the harmful comments made by Minneapolis City Council member Michael Rainville at a community meeting where he blamed the Muslim Community and Somali youth for the crime and unlawfulness that took place on July 4 in the city. We did not attend the meeting, but we have heard from many constituents who, like us, found his comments both dangerous and unacceptable. Since the community meeting, we have both had discussions with Council member Rainville to express our disappointment and to urge him to meet with members of both the Muslim and Somali communities to advance his understanding of those communities, and to hear why his comments were so hurtful.

While Council member Rainville has apologized, we are all accountable for our actions. As state legislators we do not have authority to hold individual city elected officials accountable. We urge his city colleagues to determine what next steps should be taken for accountability.

We remain committed to supporting and protecting all of our constituents, including our Somali and Muslim neighbors. Elected officials must be held to a higher standard and should not amplify stereotypes with hurtful and dangerous statements. Instead we should be building connections and community trust. We stand ready and remain committed to rebuilding and expanding that trust."

Minneapolis Delegation condemns Council Member Rainville's remarks

Minneapolis, MN - Last Friday, Minneapolis City Council Member Michael Rainville made public comments at a community meeting on public safety, in which he unfairly and incorrectly blamed Somali youth and the Muslim community as being responsible for the recent crime in Minneapolis. Members of the Minneapolis Delegation in the Minnesota Legislature released the following statement condemning Council Member Rainville's remarks:

"We strongly condemn the comments made by Council Member Rainville, specifically that he would be 'going over to a mosque in Northeast to meet with Somali elders and tell them their children can no longer have that kind of behavior.' That kind of prejudiced language has no place in our city, no place in our party, and no place in our elected offices.

"Council Member Rainville's comments are not only divisive and disrespectful — they are representative of a politics which leverages fear and perpetuates systems of inequity and discrimination. This does nothing to make our city safer. The suggestion that Somali youth and our Muslim neighbors are disproportionately responsible for recent crime in Minneapolis is as racist as it is inaccurate. Amplifying anti-Somali and Islamophobic sentiments — especially as an elected official at an official event — erodes community trust and emboldens those with hateful beliefs to justify harm and over-criminalization.

"Although Council Member Rainville has since issued an apology regarding these statements, we urge him to make good on his promise to 'meet with community members' by holding public accountability forums to discuss why his actions are harmful and how he can tangibly demonstrate improved understanding.

"We stand in solidarity with our Somali and Muslim communities, and urge the City Council and Mayor to take formal action to hold Council Member Rainville accountable for his behavior. As elected leaders representing Minneapolis, we are committed to protecting all our residents and ensuring accountability for words and actions which unjustly target any of them. We look forward to continuing to work with the community, city leadership, and Council Member Rainville to repair relationships and rebuild trust."

When it comes to things said by other council members, we tend to give each other wide latitude. Differences of opinion are important to share and result in more representative and diverse discussions. However, I believe recent comments by Council Member Rainville crossed a line. I know he wholeheartedly cares about addressing crime and is deeply frustrated (as am I) about what we saw over the July 4th weekend. Yet blaming a racial or ethnic community for the actions of individuals perpetuates false narratives and inflames discrimination. It causes harm and makes many of our fellow neighbors feel unwelcome. Particularly when done by a government official at an event filled with many members of the public, it can normalize discriminatory rhetoric and attitudes. I stand in solidarity with those who have spoken out to condemn such rhetoric and join the call for restorative actions to repair the harm, learn from the incident, and find a way to move forward.

A Message from Council President Andrea Jenkins

Dear neighbors,

As President of one of the most diverse city councils in Minneapolis history, I was disappointed and saddened to hear Council Member Michael Rainville's comments demonizing Somali youth. There is no place for xenophobia, transphobia, Islamophobia, sexism, racism, able-ism, in our society. The events of July fourth were despicable and cannot be tolerated. We all need to talk to our children and other young people in our lives about responsible behavior in public spaces. We as a society need to create opportunities for recreation and entertainment that is safe and enjoyable for everyone.

I was encouraged to see Council Member Rainville's apology, and I am aware that ethics complaints have been filed against him. The results of the investigation will determine if further action is necessary. In the meantime I encourage Council Member Rainville, and all of us, to continue to work to become anti-racist. It is a constant journey that never ends. Each and every one of us has been educated, indoctrinated, shaped and formed in this racist culture. I have to work hard each and every day to overcome internalized racism, sexism, homophobia, transphobia, etc., and I am a Black, Trans person living with a disability. We must do the work of becoming anti-racist and hold ourselves and each other accountable.

Mayor Jacob Frey said Rainville's concerns about violence were valid, but his comments singling out the Somali community were hurtful and wrong. "I'm glad he apologized, and he should stick to that message," Frey said in a statement.

In an additional statement this week, Osman, the only Somali American on the council, said he has spoken with Rainville several times about the hurt his comments have caused in his Somali community. Osman said he's willing to forgive Rainville and work with him through the matter because " [Rainville] has shown a willingness and a desire to get to know the Somali community unlike any of the other council members I've worked with."

"He has apologized," Osman said. "He said something he should have thought about more and is taking responsibility for that. From the very beginning he has shown up in the community, engaged with faith leaders and been willing to learn. I hope Council Member Rainville will take this as an opportunity for growth and a chance to strengthen his ties to the community."

In particular, the article involves possible formal steps, such as the ethics complaints and the rules governing a motion to censure by the City Council. Council members are reported to have differing opinions on whether to wait for the result of the Ethical Practices Board process before adopting a motion to censure CM Rainville. Additionally, CM Rainville is reported to have a private meeting schedule for the evening of Friday, July 15 with Somali American leaders and youth.

Council President Andrea Jenkins said in a recent interview that the council "can potentially censure" Rainville, but she'll await findings of the ethics investigations "before that happens."

But others on the City Council, including Council Member Jeremiah Ellison, say the don't need an ethics board investigation to know whether Rainville's comments were "xenophobic, racist and condescending" and that they must move quickly to condemn Rainville's remarks.

Rainville is now set to have a private meeting Friday evening with some Somali American leaders and youth. The aim of the meeting is to help him better understand how his words impacted a group of people already experiencing an increase in anti-Muslim sentiments.

There's also talks for a public meeting between Rainville and residents in the near future.

On July 8th, Council Member Michael Rainville who represents Ward 3 held a community meeting to discuss incidents that occurred over the 4th of July weekend. It was during this meeting that Council Member Rainville made racist, inappropriate, and deeply harmful comments about our Somali and Muslim community, particularly youth. Rhetoric of racism, Islamophobia, and xenophobia is dangerous and leads to targeted efforts that are often violent towards our Somali, Muslim, and Black communities.

It shouldn't take the communities impacted and other advocates to ask for support in condemning this behavior. Read here Council Members Osman, Ellison, and my joint statement. I am committed to working alongside my colleagues on the Council with community members to continue asking for formal accountability and condemnation. It is crucial that we center the voices and needs of our Somali and Muslim neighbors.

10:50 AM - Following a meeting with Council Members Michael Rainville and Jamal Osman, the Somali Student Association releases a <u>statement</u> thanking CM Rainville for the meeting and reiterating the association's priorities for public safety.

Previously, we had released a statement condemning the inconsiderate remarks by Council Member Rainville. We still unequivocally stand by our statement. In the statement we had called for a meeting with the mosque elders, congregants, community members and leaders with CM Rainville and held the meeting at Dar Al-Qalam this previous Friday after prayer. Previous, to setting the meeting, members of our board discussed at length with the mosque elders, asking for permission to host the meeting there as well as their reactions to CM Rainville's comments. We were pleased to hear that CM Rainville visited the mosque the following day after his remarks to apologize and not chastise our elders and community members for the crimes and despicable behaviors on July 4th that were perpetuated by criminals and hooligans of all walks of life. The apology came at an opportune time as it was in front of a congregation of over a thousand, which were celebrating Eid Al-Adha. We also learned that previous to his comments and before he become an elected official CM Rainville would visit the mosque on multiple occasions working towards building a relationship with the community there. And while serving as a council member, assisted in connecting them to resources and officials after a recent Islamophobic attack at the mosque. We are pleased that CM Rainville has actively worked to develop a relationship with the community before his insensitive remarks and hope that he will continue to build inroads within the Somali community he serves. However, while the council member apologized, he and all of us know his comments have a broader affect not only how people view the Somali community but also how systems of government will perceive the community. In the meeting, our goals were unchanged from those previously stated in our statement on July 9th. We held the meeting for multiple reasons to address how his comments inextricably harmed the Somali community and for him to hear that firsthand from the people who are from that community. As well as to find positive ways to move forward that will benefit the community and address the harm his words caused. In our conversation, we discussed public safety and the concerns of the Somali community. Concerns over public safety is not limited to the lines that divide wards or socioeconomic status. However, certain solutions within public safety have had drastic results in communities of color. We discussed the importance of communities having resources to address public safety outside of policing, crime prevention and drug cessation programs for youth and young adults that are culturally responsive and relevant. We strongly emphasized the city's behavioral response team to become more culturally competent and reflective of the communities they would serve. Building inroads and trust within communities predicated on better-trained officers, community engagement, recruitment and promotion of officers of color and officers who live within the communities they serve. Before CM Rainville's callous broad-brush remarks he determined it necessary to build positive relationships with the Somali community he represents. We hope and believe that CM Rainville will take this as an opportunity to not only build upon those nascent relationships, but also mend the harm caused

12:38 PM - Liz Collin publicly <u>states</u> that CM Rainville was aware the interview was for Alpha News and indicates she spoke with CM Rainville regarding an earlier story. (CM Rainville's staff claimed that CM Rainville's quotes had been pulled from other sources.)

5:37 PM - Star Tribune releases an <u>article</u> by Faiza Mahamud discussing reactions to CM Rainville's comments and his recent meetings with members of the Somali community, including the recent meeting with the Somali Student Association. The article notes that CM Rainville "has promised to work with Minneapolis Mayor Jacob Frey and council members to provide some funding for the Somali community, particular the youth in the upcoming budget," according to CM Osman. The article also notes that "Rainville has not responded to interview requests from the Star Tribune, and his office did not answer wide-ranging written questions that included what support for youth and community would look like."

5:44 PM - County Commissioner Irene Fernando (District 2) issues a <u>statement</u> condemning CM Rainville's comments, encouraging CM Rainville to "remove himself from entities where his

discriminatory views will negatively impact efforts to foster equitable community safety, including the Criminal Justice Coordinating Committee." The statement also notes that CM Rainville "backtracked and demonstrated that he had not been communicating with me in good faith. It became clear that he was not planning to hold a public community meeting as demanded by his Muslim colleagues, and that his communications with me had been an effort to stop me from speaking publicly on this issue." Commissioner Fernando also states that she supports "efforts by Councilmember Rainville's city council colleagues to take formal and public accountability measures to condemn his racist remarks and hold him accountable."

On July 8, Minneapolis Councilmember Michael Rainville made racist and Islamophobic comments stating that Somali youth perpetrate an overwhelming majority of crime in our community, without any evidence supporting this harmful claim. He then made a subsequent trip to a mosque in Northeast Minneapolis to tell Muslim leaders that their children must stop this behavior, which is especially discriminatory to me since none of the individuals arrested the night he referenced were from Northeast Minneapolis.

Today, I join numerous elected officials and community leaders in fully condemning the Councilmember's disturbing and damaging remarks.

Statements like his lead to the further criminalization of already over-policed communities. Further, in a time when we are witnessing increased incidents of hate crimes against marginalized communities both across the nation and here in Minnesota, his divisive comments encourage fear and resentment towards our Somali neighbors and create a permission structure for individuals predisposed to racist violence to act out.

Councilmember Rainville and I have a shared jurisdiction (we both serve Minneapolis Ward 3 precincts 1-3, 5, and 6), and additionally I am the commissioner who represents Northeast Minneapolis. Many of our shared constituents and impacted residents have expressed concern and horror to me over his comments.

Since early last week, I have sent several formal communications to Councilmember Rainville for the purpose of:

- · communicating the harm he had caused to community members,
- expressing that his comments were out of line with my values and leadership commitments,
- encouraging him to remove himself from entities where his discriminatory views will negatively impact efforts to foster equitable community safety, including the Criminal Justice Coordinating Committee that he and I both serve on, and
- stating that until he took specific actions to remedy the harm he caused, I would be unable to work with him or his office because his discriminatory views prevent collaboration and partnership (specifically holding a public meeting to allow community members to share the impact of his comments as was requested by his Muslim colleagues).

Councilmember Rainville initially responded saying that he was working with the elders of the mosque he had visited to host a community discussion. However, he then backtracked and demonstrated that he had not been communicating with me in good faith. It became clear that he was not planning to hold a public community meeting as demanded by his Muslim colleagues, and that his communications with me had been an effort to stop me from speaking publicly on this issue.

I prioritized a one-on-one approach before making a public statement to encourage him to receive feedback and hold a public meeting as requested by our shared constituents. But it is clear, from his meager apology and his approach to my emails, that Councilmember Rainville does not understand how horrendous his comments were. It is important that he does — and I intend for this statement to show him how seriously his fellow elected leaders are taking the incident and his words.

I fully support efforts by Councilmember Rainville's city council colleagues to take formal and public accountability measures to condemn his racist remarks and hold him accountable. His behavior is far outside of the expectations we should have for elected officials, and I will not work with his office until he takes the corrective actions outlined by his colleagues. We must hold electeds accountable for their actions. And to the residents who have shared their experiences of harm, I thank you for stepping forward and I continue working diligently to ensure everyone in our communities feels safe.

Full audio is available here and Wedge Live's reporting is available here. CM Rainville makes reference a few times to how he knows he is being recorded now.

Talks about a need to support police and remarks on how the barricades on the street can improve public safety. Asks for constituents to submit feedback regarding the upcoming street reconstruction. Acknowledges a need to improve training for MPD and talks about the importance of the new "duty to intervene" policy. Supports nomination of Dr. Cedric Alexander to be Community Safety Commissioner.

Some residents express discomfort with the idea of wealthy neighborhoods getting more policing because they can pay for it. (Context: MinnPost article on this subject) CM Rainville gives a fairly neutral response to the question, however, separately CM Rainville has been part of fundraising efforts to hire off-duty cops in the Mill District.

CM Rainville suggests that residents encourage young people to become police officers and assist with recruiting. Also encourages residents to call 911 a lot, even for nuisance crimes so that these calls are included in the crime statistics for the area.

I want to be clear on the public record that I condemn these comments. Racist, xenophobic, and reactionary language from elected leaders moves us away from a city where everyone is safe.

Rainville's remarks were more than "unfortunate"

Regarding the editorial in the previous issue, using words like "scofflaws" and "miscreants" to describe real public safety concerns dismisses the seriousness of what needs to happen. It also focuses on the individual, not systemic changes. The public safety concerns of Minneapolis will not be addressed by a meeting at a mosque and lecturing parents on the supposed behavior of their children. They will be addressed when we have a department of public safety that is adequately staffed with qualified professionals like mental health responders, homeless outreach and trauma specialists. If Council Member Rainville is serious about this, he'll look to implement systemic changes and address societal needs—expanding affordable housing, fully funding youth programs, pushing for livable wages, etc.

Rainville's remarks were not unfortunate; they have an impact on Somali kids and families in our ward, and beyond. They are not a distraction from the work needed to create a system of public safety that keeps all of us safe; they are a reminder that race-based divisiveness like this are barriers that must be dismantled to have true public safety. And that is more than an apology and community meetings. Rainville needs to be public about his next steps and communicate them to all constituents. This is not a time for silent personal development. What he does can set a tone for our ward-committed to being welcoming, and ensuring we all can thrive, regardless of our race or background. This requires him commit to being anti-racist, not using racial dog whistles to talk about our community and rejecting this recent oblivious status quo style of "leadership."

Northeaster's editorial was inappropriate

We as community members write in response to the way Council Member Rainville's racist and xenophobic comments about Muslim youth were discussed by the Northeaster's Editorial Board last issue in "Violence touches NE."

When a council member who was elected to represent all the residents of an area makes a comment like "95% of the issues [on July 4th] were caused by Muslim kids" that is demonstrably false (a simple review of those arrested from the incident demonstrates this) it is more than "unfortunate" and a "distraction." When the three Muslim members of the City Council take time from their holiest holiday weekend with family and community to eloquently state the effect their colleague's remarks made on the children, families and residents in their communities, that isn't "virtue signalling" - it's being a good representative, unlike what Rainville demonstrated. People whose communities and children were singled out have every reason to react the way they did, and the staff of the Northeaster has no right to refer to those reactions as "distractions."

The Northeaster Editorial Board seemed to want to excuse Rainville's statements as somehow acceptable, reducing and excusing the harm caused to an often marginalized community. Was the Editorial Board aware that the entire Minneapolis House and Senate delegation condemned Rainville's racist and Islamophobic statement, including Sen. Kari Dziedzic, Rep. Sydney Jordan and Rep. Mohamed Noor, who himself is a member of the community Rainville singled out and targeted? Were they "virtue signaling," or is that a term reserved for council members whom the Editorial Board disagrees with?

Rainville thought his words would stay at Kramarczuk's that morning. Why did the overwhelmingly older, white residents cheer when he said he was going to a mosque to scold parents on the behavior of their children, on one of the holiest Muslim holidays, Eid al-Adha? Those reading this should examine their own racism and motivations if they found a swift reaction to this from community members a "distraction" or "virtue signaling."

Further, it is the Mayor, not the City Council, that has full control of MPD, so the Ed Board's call for the City Council to somehow use power they do not have to ensure MPD is fully staffed was also puzzling. Short of the CMs signing up to work as police officers themselves, what does the Ed Board suggest they do? MPD already has more money than they could spend last year, and the Council approved it, so they've done their job when it comes to public safety; now it's time for the Mayor to do his.

Finally, the solutions that the Ed Board lauds that Rainville advocated for never seemed to be available for other communities that experience violence - it wasn't until a predominantly White and affluent neighborhood was touched that the response was swift and at all an option. Young people all across the city could use the resources now being thrown at barricades, patrols and metal plates; they just don't seem to live in the right zip codes.

We believe the hardworking volunteers of Senate District 60 DFL said it very well in their response to this matter when they noted: "We believe support for Minneapolis youth should be rooted in community, care and restorative practices. We call on Council Member Rainville to repair the harm he caused and seek restorative reconcilitation." We as neighbors call for the same for Rainville and for the Editorial Board who thought their response was in any way appropriate to his actions. Perhaps the Ed Board and Rainville could together neet with Edison High School's student council and hear directly from the youth of Northeast what support they need to make Minneapolis a safer city for all of us.

3:00 PM - The Ethical Practices Board held its regular meeting. Probable cause was found for one case and the others were dismissed. It is not known if any of these cases relate to Michael Rainville.

6:14 PM - Michael Rainville announces his re-election campaign.

It is ultimately impossible to predict how situations like this will unfold. This will depend on further developments, including what other information is unearthed by journalists, what further actions and statements Council Member Rainville makes in the future, and the reactions to all of this by elected officials, the party, and the public.
