They hosted a Family Night at the Carnival with over 60 families completing the scavenger hunt form.
- FFA/Agriculture: Ms. Limbach and Mr. Naros discussed how they are incorporating hands-on learning in their classrooms; our FFA organization has over 90 members, and discussed current events such as the Labor Auction, Greenhand Conference, working on State degrees, shooting sports, and creating a new BBQ competition team.
