Restore My All Deleted Photos ("us", "we", or "our") operates the Photo Recovery mobile application (hereinafter referred to as the "Service").

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our Service and the choices you have associated with that data. Definitions

Service

Service is the Restore My All Deleted Photos mobile application operated by Naftech.

Personal Data
