Dear Parents/Guardians

Students will have the opportunity to go on numerous field trips throughout the school year. Some of the field trips will just be during their class hour and will be as simple as going down to the show barn. Other trips will include students missing school for the day. It may also include overnight trips to leadership camps. However, with this being said we will require a blanket activity trip form to be kept on file.

While participating in Agricultural Education and FFA Activities, hosted by local, state, and National FFA Organizations, there are certain behavior expectations that must be observed by all participants to maintain good standing with the FFA and participation in these programs. All participants in an event, or activity sponsored by the FFA are prohibited from involvement in unsafe, irresponsible and/or illegal conduct. These events are approved by Webbers Falls Public Schools and are an extension of the school day. Therefore, hotel rooms, bags and luggage are subject to search at any time. In addition, you must abide by all rules and regulations established by local, state and National FFA for participation in these activities.

1. I promise that my attitude, conduct and appearance will be in such a manner that reflects credit on my school, community, and The National FFA Association.
2. I promise to abide by the FFA Code of Ethics as outlined in the Official FFA Manual.
3. I will be well-groomed, dress appropriately, and abide by the official dress standards set by the National FFA Association. The Webbers Falls Public School dress code will be followed during all FFA activities. I agree to use my cell phone and all electronic devices at the appropriate times.
4. I will not be in the hotel room of another participant of the opposite sex. I will respect hotel properties as if they were my own. I will pay for all personal costs and any damage of hotel property directly to the hotel before I depart. I agree to keep the room assignment given to me at registration. I understand that room checks will be conducted at a designated time, and I must be in my assigned room. I will not leave my room for any reason after that time.
5. I will not possess or use drugs, alcohol or tobacco at any time during any activity. I understand that firearms and knives are strictly prohibited. Failure to abide by these rules will result in immediate dismissal from the activity and my agricultural education instructor or parents will be notified.
6. I agree to stay with my chapter at all times unless directed otherwise. I understand that going on my own anywhere on any activity is not allowed.

Local, State and National FFA staff reserves the right to dismiss anyone who is found to have violated these behavioral expectations. Students dismissed from any FFA activity will be sent home and will be responsible for all expenses associated with their dismissal and transportation home if needed.
