1. **Hiring Committee**

2. **Apparel Committee: Jessica Sisul**
 - a. A fan apparel order will come out at the beginning of the season
 - i. T-shirts, tank tops, hats, visors, bucket hats will be available for order.

3. Fundraising Committee: Crystal Boender

- a. Swim-A-Thon to be held during 2023 winter break
- b. Nathan Pollard will be contacting Thelma's Chicken about doing a fundraiser during the 2023 summer season.

4. Finance Committee

- a. Updates were made to the FIN Fund account.
 - i. It was proposed that the amount offered to families who qualify for the FIN Fund be changed from 20% of fees to 50% of fees and the limit per family be removed. Jessica Sisul motioned to approve the updated wording. Crystal Boender seconded the motion. Motion called to a vote and passed. The policy will now read: "If eligibility is met, families will be qualified for a discount of 50% per family on SEA programming fees for one year." The policy no longer has a limit of \$200/family per season.
 - ii. It was proposed that the FIN Fund be used to reimburse registration fees and background checks for those becoming non-athletes in order to be on deck as a 1-1 with special needs swimmers. Nathan Pollard motioned to approve the proposal. Amber Green seconded the motion. Motion called to a vote and passed.
- b. Head Coach's Salary: At this time, the head coach's salary will remain at an hourly rate.
