III. Agenda Items

- 1. Announcements. Erik wants to review bylaws and election of board members. Discussion of who will still be board members and who has an option to be reelected. Ron, Eric and John and Todd are automatically renewing.
- 2. Review bylaws regarding elections. Bylaws were reviewed in 2020. Section 6 states you need at least 3 board members and no more than 9. One or two people are rolling off.
