Superintendent/Principal Report:

Superintendent Hawley reported on the following items.

- Superintendent Hawley congratulated the Girls Volleyball Team for back to back State Championships. The coaches and the girls did a great job this season.
- FFA hosted the Green Hand Convention, there were roughly 150 students on our campus. "Mrs. O'Toole is doing a great job with our FFA kids." The kids stayed in the Elementary Gym and the Crane Fellowship Church. Thank you to Crane Fellowship church for allowing us use of your facility.
- The elementary kids did a walk through the high school in their Halloween costumes, then went back for their classroom parties. Halloween night the PTO put together a Trunk-Or-Treat, parents and kids had a good time.
- The Winter Sports Schedules were presented.
- The Elementary School Christmas program will be held December 19th at 6:00 pm. The Middle School will do all the set up and clean up.
- There was a great turn out in the Middle School and Elementary for Parent Teacher Conferences.

A question was raised how many paid coaches does the Boys Basketball team have. Mr. Nichols answered saying there are two paid Boys Basketball Coaches. The rest are volunteer.

Principal Report:

Principal Nichols reported on the following items.

- Mr. Doman and Mrs. Joyce took kids to OIT for a campus tour.
- The Financial Aid Scholarship dinner and information night will be held tonight. They will have dinner in the cafeteria at 6:00 with the meeting at 6:30.

Items for Action:

Discussion Items:

Superintendent Hawley presented for discussion the following items.

- The Ag complex is coming along, it is going to be a state of the art building. The
 construction company says it should be done by the end of November.
- Mr. Nichols reported on the SIA Grant. The ODE has tasked us with responding to two
 reflection questions. The first question pertains to our progress toward our stated
 outcomes and strategies, and our long term goals. The second question pertains to
 barriers and challenges we have faced in implementing our IG plan and how the ODE
 can be of support. Mr. Nichols told the board that like all grants the SIA dollars come

with "strings attached" We are continuing to make progress toward the outcomes and strategies in our IG plan. We offer well-rounded education opportunities to our students. Our CTE program continues to grow. We have extra teachers and have a full time counselor. All SIA funds were spent by both districts, following the criteria that was selected.

- ORS "Failing to Supervise a Child" Policy Discussion. Mr. Hawley is going to attend a
 meeting with Harney and Grant school administrators and will bring back more
 information.
- Board Vice-Chair Mark Owens talked with Mr. Hawley and asked if he could be removed as the Vice Chairman of the District 1J Board. There will be many meetings he will need to attend by zoom and does not feel he can adequately do this job. The board decided to take action on this item tonight.

William Dunten moved to remove Mark Owens as the District 1J Board Vice-Chair, Mike Davis seconded and the motion carried unanimously. William Dunten then nominated Mike Davis to fill this position, Dan Otley seconded and the motion carried unanimously. Mike Davis will now be the vice chairman.
