1. A. Asking People PEWDIEPIE vs T SERIES on OMEGLE (5:40 - 5:51)

- B. In the specified timestamp, Shelesh shows a seemingly underage couple around the ages of 14-17. The girl in the clip is wearing rather skimpy clothing and begins fondling her breasts. Shelesh encourages her to fondle her breasts by telling her to "do that again." Although she censors the fondling with an emoji, part of the girl's breast becomes visible for a brief split second. A backup of the video can be accessed here on the Internet Archive in case Shelesh deletes the video.
- C. Encouragement of sexual interactions with alleged minors, partial nudity of alleged minors.
- D. Feb 23, 2019

2. A. **GIRL ON OMEGLE** (2:04-2:41)

- B. In the specified timestamp, Shelesh interacts with a girl who claims to be 16 years old, who offers to lift up her shirt to flash her breasts. Shelesh lies about her age claiming to be 15 years old as well when she was in reality at the age of 24 during the time of the incident. The girl lifts up her shirt revealing her breasts to Shelesh, and this moment of the video is the most rewatched clip in the video which has over 2 million views. The video has since been removed by Shelesh after being called out for it on Twitter by popular Youtuber TheRealSullyG in this tweet. This video was not backed up on the Internet Archive before deletion.
- C. Nudity, sexual remarks to an alleged minor, lying about age to sexually interact with an alleged minor.
- D. Dec 24, 2016.

3. A.<u>DO YOU WANT TO HAVE MY BABIES | OMEGLE TROLLING (0:37</u>-1:31, <u>5:08</u> -517, 6:07 -6:25)

B. In the first timestamp, Shelesh is talking with a girl who looks to be around 13-15 years old and talks about impregnating her and wanting to have a child with her. In the second clip she matches with someone who allegedly starts to show her bestiality porn of a woman having sexual intercourse with her dog. Instead of immediately clicking off and hitting the next button, she watches in shock. The porn is poorly cropped out of the video with a single frame of it being left in alongside Shelesh's reaction. In the third

timestamp, a boy who appears to be around the 15-17 year old age range is talking with Shelesh about how he feels like there is an issue where a lot of people on Omegle are showing their penis. Shelesh then is coercing him into thinking she has a penis to trick him into saying that he wants to see if she has one or not. He clicks off when she gets up to reveal her vagina (which she never does) and then she jokes about getting a packer (a fake penis usually used for transgender men to feel gender affirmation) just to mess with people if they ask about if she has a penis. A backup of the video can be accessed here on the Internet Archive in case Shelesh deletes the video. As of October 24th, 2023, this video has been age restricted but has not been taken down from Shelesh's channel.

C. Sexual remarks towards an alleged minor, possible consumption and distribution of bestiality pornography, coercion of an alleged minor, attempted flashing to an alleged minor.

4. A. THE MEANEST GIRL ON OMEGLE | Omegle Funny Moments (6:13-6:19)

B. In the specified timestamp, a girl, who appears to be around 16-17 years old lifts up her top for Shelesh and she comments about the size of her breasts. The video censors the breasts with a "Troll face" reaction image. This video has since been deleted from Shelesh's channel after the publishing of this document. A reupload of the video can be found here on the Internet Archive.

- C. Partial nudity of an alleged minor.
- D. Apr 22, 2016

5. A.Mom Caught Kids Twerking! (Funny Omegle Moments)

- B. This was the first of Shelesh's videos with sexual exploitation of minors that was discovered and she has since privatized the video to cover her public image after being called out for it on social media platforms. The first clip in this video showed a boy who looked to be around 16 with an erection in his pants that was clearly visible to the camera. In the second clip she coerced two boys around age 13-14 to perform sexual dance moves colloquially referred to as "twerking" in which the performer of the act shakes their butt in a sexually suggestive manner. Shelesh does this by telling the underage boys that she would show them her bare breasts if they performed the action for her. A reupload of the video can be found here on the Internet Archive.

6. A. <u>OMEGLE TROLLING | PICKING UP GIRLS ON OMEGLE</u> (0:28 -0:39, 4:07-4:10, 5:15-5:26)

B. In the first timestamp, Shelesh stands up for two teenage girls to show off her body. The actual part of her doing so is cut out. Afterwards, the girls are naked for her, but the image is blacked out due to youtube censors. In the second clip, a girl who looks about 14-15 takes off her shirt for Shelesh as they both say they want to get naked for each

other. This part is the most replayed part of the video on Youtube.In the third timestamp, a girl who looks about 16-17 cuts off her top and her bra for Shelesh. This video has since been deleted from Shelesh's channel after the publishing of this document. A reupload of the video can be found here on the internet archive.

- C. Sexual images of an alleged minor, offering of sexual activity towards alleged minors.
- D. May 21, 2016

7. A. HARLEY QUINN TROLL ON OMEGLE (6:51 -7:17)

- B. Shelesh notices that these young girls are wearing an absurd amount of clothing and tells them to take all the layers off in a sexually charged manner. This video has since been deleted from Shelesh's channel after the publishing of this document. A reupload of the video can be found here on the Internet Archive.
- C. Coercion of alleged minors
- D. Aug 13, 2016

8. A. <u>JEALOUS GIRLFRIEND ROASTS ME ON OMEGLE</u> (3:32 - 3:43)

- B. In the specified timestamp, Shelesh openly says that she finds someone attractive whom she acknowledges is underage. A backup of the video can be accessed here on the Internet Archive in case Shelesh deletes the video.
- C. Sexual remarks towards a minor.
- D. Apr 8, 2017

9. A. <u>INSANE BEATBOX GIRL ON OMEGLE</u> (2:55 - 2:57; 7:06 - 7:32)

- B. In the specified timestamp, Shelesh makes a sexual comment about a seemingly high school girl; saying her beatboxing makes her want to twerk. In the second specified timestamp, Shelesh flirts with someone who, at 7:30, seems to utter "I'm too young [for this]" before she cuts him off. She flirts with him by asking him to be her "papa" in a flirtatious manner. A backup of the video can be accessed here on the Internet Archive in case Shelesh deletes the video.
- C. Making sexual comments with an alleged minor; flirting with an alleged minor who expresses discomfort with her sexual comments.
- D. Feb 4, 2017

10. A. MOST DISGUSTING PERSON ON OMEGLE (0:50 - 2:31)

B. In the specified timestamp, Shelesh flirts with someone who, at 1:20, appears to say "I'm still like uh [underage/too young]" before she cuts him off. While flirting, she asks him if he could be her sugar daddy and pay her bills, as well as discusses general romantic fantasies. A backup of the video can be accessed here on the Internet Archive in case Shelesh deletes the video.

- C. Possibly flirting with a minor.
- D. Jan 13, 2018

11. A. <u>WILL YOU BE MY GIRLFRIEND | OMEGLE FUNNY MOMENTS</u> (2:37 - 2:44; 3:15 - 3:27; 6:42 - 6:44)

- B. In the specified timestamp, the video cuts to Shelesh encouraging a teenager to twerk. In the second specified timestamp, Shelesh eats a cookie in a lewd manner in front of a girl who is likely underage. In the third specified timestamp, she says to two underage girls, "Sorry; I'm not a big penis." This appears to make the girls uncomfortable based on their response to her sexual comment. This video has since been deleted from Shelesh's channel after the publishing of this document. A reupload of the video can be found here on the Internet Archive.
- C. Encouraging a minor to engage in lewd acts. Eating food in a lewd manner in front of someone who is likely underage. Making a sexual comment towards girls that made them uncomfortable. All of these people are allegedly underage based on their appearance.
- D. Aug 5, 2016.

12. A. <u>MUSICALLY GIRL ROASTS ME ON OMEGLE</u> (3:31 - 3:35; 5:08 - 7:28)

- B. In the specified timestamp, Shelesh acts jokingly lewd towards a girl who stated she is underage at 3:05. In the second timestamp, Shelesh jokingly claims to be the girl's mother. While the punchline begins with their age gap, it devolves into lewd undertones as the joke progresses. The girl shows pictures of Shelesh in lewd cosplays and in lewd positions with her boyfriend of the time, Evan Young. Shelesh plays on this by joking about the sexual activities she and Young engaged in before she "had her." The clip ends with her joking that the minor was born from Young due to his being overweight. A backup of the video can be accessed here on the Internet Archive in case Shelesh deletes the video.
- C. Makes a lewd joke to someone who stated they are underage beforehand. Jokes about being the same minor's mother, but devolves into having lewd undertones as they roll along with the joke.
- D. Apr 22, 2017

13. A. <u>READING PEOPLES MINDS ON OMEGLE</u> (10:08 - 10:12)

- B. In the specified timestamp, Shelesh is talking to three seemingly underage children. One of them gets excited after recognizing her and asks what videos she makes. She jokingly responds with "Porn." A backup of the video can be accessed here on the Internet Archive in case Shelesh deletes the video.
- C. Making a sexual joke with seemingly underage children.
- D. Sep 26, 2017

14. A. CRAZY TWITCH STREAMER ON OMEGLE (8:22 - 8:30)

- B. In the specified timestamp, Shelesh encounters a seemingly underage boy who claims he has to do a wedgie because he lost a bet, and later says he has to be humiliated for losing the bet. Shelesh agrees to watch him attempt to give himself a wedgie. The nature of these conditions for a lost bet seem to be sexual in nature, yet she allowed for the supposed minor to do them in front of her anyway. A backup of the video can be accessed here on the Internet Archive in case Shelesh deletes the video.
- C. Possibly assisting a possible minor in what is seemingly their sexual fantasy.

D. Apr 1, 2017.

15. A. PRETENDING TO BE SSSNIPERWOLF ON OMEGLE (10:45 - 12:18)

- B. Needed context: In the beginning of the video, Shelesh clarifies to her audience that she has hired an actress to impersonate her and pretend to be her on Omegle. She is still culpable for the following incident because she has distributed and assisted in this interaction being possible. In the specified timestamp, the impersonator and the unidentified voice that sounds underage discuss flashing each other's genitals to each other in a somewhat joking manner. The impersonator then suggests the voice pay her money in exchange for porn/nudes of her. They continue talking about this for about ninety seconds. - C. Aiding and abetting sexual interactions with a potential minor; distributing said interactions with a potential minor.
