## Mick Mars suing Motley Crue over missing wages!

So Mick Mars sued Motley Crue and the story keeps getting weirder and weirder! We've seen some new developments over the past week but to give you a bit of context:

Last week TMZ (everybody's worst fever dream) reported that former Motley Crue guitarist Mick Mars was suing his former band over his "retirement" from touring, which he alleges was total bullshit, and that he's actually been kicked out of the band, which also means his tour profits were slashed. Oh, and also apparently Nikki Sixx doesn't play live. Just to throw more shade into the mix.

Adding that he wanted to speak from his experience in order to "warn other musicians who could one day find themselves in a similar situation."

"I think to safeguard any other people that may be coming around to being in this position that may well be acquaintances of mine or even good friends of mine, I wouldn't like them to be in the same position."
