#### Physical Description:

#### Background:

After a botched bank robbery in which he accidentally but fatally shot a bystander, Gordon Walker received the death penalty, and his brother Jacob Walker received a lesser sentence for his involvement. Gordon and Jacob were transferred to the now defunct Site-73 as part of a "package deal" that assigned them as Class-D personnel. The brothers escaped a week into their confinement at Site-73, joining the nearby Cell Omega as conscripts. Shortly after their recruitment, then-Private First Class Jacob Walker was declared MIA, and Gordon periodically takes leave to continue the search for his brother.

Despite a lack of formal education, Gordon joined the Cell's Research and Development branch. He now specializes as an anomalous field researcher, and has served twice as RND Co-Lead. Gordon exhibits a generally nonchalant personality, but has a deep sense of loyalty to his fellow Insurgents and has adapted to a wide variety of situations, anomalous or otherwise.


