Fanart/Fan Characters	<u>SELF-HARM (specifically the act of conducting self-harm. Scars are okay)</u>
MILD Nudity/Suggestive	
Creatures/Species (original or not)/Hybrids	
Humanoids (depends)	
GORE (pastel/not pastel/candy)	
Couple/Ship (IF IT IS LEGAL!)
