### **ACTIVITY WAIVER for PRPS INTERNATIONAL STUDENT PROGRAM EVENTS**

I/We, the aforementioned parent(s) or guardian(s), grant our son/daughter permission to participate on all field trips, clubs, sports teams, and outings/activities during his/her stay in Canada. Outings and activities include those planned by Prairie Rose Public Schools International staff, his/her homestay family or dormitory staff, and/or his/her school. Students participating on outings or activities that are (1) overnight or (2) outside of Alberta will require additional permission.

Activities and outings may include (but are not limited to) skiing, snowboarding, skating, tobogganing, swimming, camping, hiking, boating, fishing, amusement park rides, horseback riding, rollerblading, soccer, baseball, football, hockey, volleyball, basketball, and all related transportation.

I/We understand that our son/daughter is prohibited from participating in certain activities that are not covered by his/her medical insurance while in Canada. These activities include motorised contests of speed, parachuting, skydiving, hang gliding, bungee jumping, cave exploring, mountaineering, rock or cliff climbing, or scuba diving; operating any type of aircraft or travelling as a passenger on any non-commercial flight; operating any form of motorised transport on land or water without a licence valid for the area where operating; and travelling in or on a motorcycle, snowmobile, or any kind of vehicle while racing or off-road, unless no roads exist in the area in question. I/We understand that loss or injury incurred while engaging in such activities will not be covered by medical insurance and that I/we will be fully liable for all related expenses.

As the parent(s)/guardian(s) of the student mentioned above, I/we understand the risks involved in participation on field trips, clubs, sports teams, outings, and activities, and absolve Prairie Rose Public Schools Division of any liability or financial obligation resulting from loss or injury.

## CONSENT to USE and DISCLOSE PERSONAL INFORMATION

In accordance with the *FOIP Act* and the *Copyright Act*, Prairie Rose Public Schools (PRPS) requests consent for various purposes, as outlined below. Consent is voluntary and can be revoked at any time by notifying the Principal in writing. You will be provided with an opportunity to verify your consent annually. If you do not return this form it indicates a refusal to consent. If you have concerns regarding these matters, please contact the Principal of the school your child attends.

### A. Appearing on Websites

PRPS on occasion posts student personal information including full name, photographs, recordings and/or interviews on district and school websites. Your consent is requested to use your child's personal information for this purpose. Please note that in the context of ordinary internet use, student personal information may be copied, altered or moved by anyone who visits these websites; and if your consent is withdrawn, PRPS will remove the image and/or personal information from its website however it may be available on the internet indefinitely.

### B. Appearing in the Media

PRPS on occasion authorises media and outside organisations to photograph, record and/or interview students while under its supervision. ## **INTERNATIONAL STUDENT REGULATIONS AND AGREEMENT**

*Below are the regulations for all students in the program including those 18 years and older. Please read carefully and sign your name after you fully understand and agree to comply with these regulations.*

### **1. Canadian Laws**

- a. Students are not permitted to purchase, possess, or shoot guns of any type.
- b. Students are not permitted to possess, purchase or drink alcoholic beverages.
- c. Students are not permitted to be in possession of false identification papers or cards.
- d. Students are not permitted to purchase tobacco or cannabis products.
- e. Students are not allowed to smoke tobacco, e-cigarettes, vape or cannabis at any time while in the program. This includes vape/e-juice that does not contain tobacco.

### **2. Dangerous Activities**

- a. Students are not permitted to drive any motor vehicle while participating in the program.
- b. Students are not permitted to participate in skydiving, hang-gliding, bungee jumping, parachute jumping, or any other dangerous activities.
- c. Students are not permitted to visit such places as pornographic shops, cannabis shops or drinking establishments including pubs, lounges and nightclubs where minors are not permitted.

### **3. Host Family responsibilities**

- a. Students must show respect for their host family and act as a member of the family by following family rules and voluntarily helping with family chores.
- b. Students should not discuss their host family's private affairs with others.
- c. Students cannot change host families and school at will.

### **4. School responsibilities**

- a. Students must follow school rules, attend school daily, complete all school assignments, must pass all classes, and maintain at least a "C" average.
- b. All relationships while participating in the Prairie Rose Public Schools International Student Program are to remain platonic.
- c. Students must always be aware of their responsibility as international students and make a determined effort to represent their country in a positive manner.

### **5. Travel**

- a. Students are not permitted to go on trips by themselves. A trip with the host family, a school group, or any other adult person may be allowed if proper approval from the Custodian and Program has been granted.

### **6. Students must show respect for all adult PRPS representatives and follow their instructions.**

*Failure to abide by any of the above regulations may result in removal from the International Student Program.*
