Storm the Bay FNO Raffle

The Oakland ARTCC on VATSIM is excited to offer pilots the chance to win a prize during the event Raffle! With the kind support of Cloudberry Simulations, iniBuilds, and FlightBeam there will be up to eight (8) available prizes for this event. Full Terms and Conditions, and Official Rules are listed below.

Promotion Description

The Storm the Bay FNO Raffle is administered by Oakland ARTCC on Vatsim hereinafter referred to as the vZOA Team. The raffle will grant eight (8) lucky winners the opportunity to win prizes from event sponsors. Raffle tickets will be available virtually until February 26, 2021 (limit 1) via the form linked on the VATUSA event posting, after which the winning tickets (and winners) will be randomly selected by computer system. Participants will be asked to provide a contact email address for notification of winnings, as well as a simulator preference (FSX, Prepar3d or X-Plane).

In order to be eligible, participants must be a Vatsim member, must complete a qualifying flight on the Vatsim network during the official event times, landing no later than 30 minutes after the event ends (9:30 PM PST, February 26th, 2021), and must provide a valid contact email address and simulator preference. To enter the raffle participants must complete a flight that departs any airport, except San Francisco (SFO), and lands at either the San Jose (SJC) or Sacramento International (SMF) airport. Qualifying flights must be at least 100 nautical miles long, measured in terms of great circle distance (not route distance). An entry by an ineligible person is void, and cannot be a winning entry. Entries are limited to one per person and are non transferable. Each participant may only win one prize. **Eligibility**

Official Prizes

The prizes for this raffle are three (3) copies of Cloudberry Simulations Oakland International scenery for Prepar3d v3 and Prepar3d v4, three (3) products-of-choice from OrbxDirect (including Orbx partner products), one (1) copy of the FlightBeam San Francisco Airport scenery for Prepar3d/FSX, and one (1) copy of the iniSimulatons A300-600R(F) on the line airliner.

Winner Selection

The entries to the raffle will end on February 27, 2021 at 8:00 PM PST and the initial winners will be contacted within 24 hours of the scheduled event end time. The winner will be chosen at random by computer generation and will be notified by email. Winners will have 48 hours to claim their winnings by responding to the email notification before a new winner is selected.

Verification of Winners

All potential winners are subject to verification by the vZOA Team, whose decisions are final and binding in all matters related to the Raffle. An entrant is not a winner, unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete. The vZOA Team will not accept photographs or other evidence of winning in lieu of its validation process. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner will be notified by the submitted email they provide when submitting their raffle entry. In the event a prize winner is disqualified for any reason, the vZOA Team will award the prize to an alternate winner by random computer drawing among all remaining eligible entries. Winner must acknowledge winning by email response no later than 48 hours after notification.

Privacy

Except where prohibited, participation in the Raffle constitutes winner's consent to the vZOA Team and its sponsors use of winner's likeness, name, and/or email for promotional purposes in any media, worldwide, without further payment or consideration. The winner's name will be announced publicly unless the winner requests in writing that they wish their name to be kept private. All participants' stored email addresses will be purged from the vZOA database no later than 72 hours after all prizes have been claimed.

General Conditions

The vZOA Team reserves the right to cancel, suspend and/or modify the Raffle, or any part of it, if any fraud, or other factor beyond the vZOA Team's reasonable control impairs the integrity or proper functioning of the Raffle, as determined by the vZOA Team in its sole discretion. In such an event, the vZOA Team reserves the right to award the prize at random from among eligible entries received up to the time of the impairment. The vZOA Team reserves the right, in its sole discretion to disqualify any individual, without compensation, it finds to be tampering with the entry process or the operation of the Raffle or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Raffle may be a violation of criminal and civil law, and, should such an attempt be made, the vZOA Team reserves the right to seek damages from any such person to the fullest extent permitted by law. The vZOA Team's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Limitation of Liability

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and the vZOA Team in connection with the Raffle, shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules (whether of the State of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of California.
