NCACAA Board Meeting Minutes June 16, 2015, 7:00pm Grandover Resort & Conference Center, Greensboro

Call To Order: President, Silas Brown called the meeting to order at 7:00pm. Eighteen agents were in attendance.

Approval of Minutes: Secretary, Jamie Warner asked if there were any corrections to the April 30, 2015 minutes. There were no corrections to the minutes. It was moved by Eve Honeycutt and seconded by Paul Westfall that the minutes stand. The motion carried.

Treasurer's Report: Becky Spearman presented everyone with a copy of the Treasurer's Report as of May 14, 2015. This report reflected the deposit that was paid for the 2016 State Meeting, the buses for the 2015 meeting and the State Secretary's Meeting Sponsorship.
