Project Timeline

Winter 2024: After finishing a semester at Laurel's first Environmental Justice program, I felt a desire to continue learning about environmental injustice within Cleveland and the networks of change and

advocacy that have worked for decades to combat these systemic inequities. I began reading about lead poisoning in Cleveland and attempting to understand its legacy in an intersectional lens. I researched and began making a list of key characters of my understanding of sustainable development and lead poisoning remediation in Cleveland.

Spring 2024: I reached out to Robin Brown of CCOAL as well as Chris Maurer of Redhouse Architecture Studio both of whom I met in my time at the semester. In this time, I completed interviews and footage with Robin and Chris and began editing their footage. I partnered with Moe Taylor of Brain Dagger Films, a pro-bono film studio. He continues to mentor me in the filming and editing logistics of the documentary process. In this time, I also reached out to Kim Foreman, the CEO of the Environmental Health Watch, and Krista Afumbom, a nurse and mother of a child who had been lead poisoned in Lakewood.

Summer 2024: I completed interviews with Krista Afumbom and Kim Foreman. Kim Foreman directed me to David Margolius, the public director of Cleveland, and Rachel Dissell, a reporter credited with bringing attention to the issue of lead poisoning in Cleveland in 2016. David Margolius introduced me to Rebecca Maurer, who worked as a lawyer to convince the city to address the issue of lead poisoning and now serves as a City Councilwoman who continues to work on this issue. I wrapped filming on the documentary at the end of August.

Winter/Spring 2024-25: I plan to have the documentary finalized by May 1st, 2025 and show it to my school community.
