As part of your registration with The Campaign Registry, you will need to provide a link to your Terms of Service and Privacy Policy. This link will need to be accessible from your webpage. We recommend putting the link or link in the footer of your website.

The Terms of Service and Privacy Policy is created so that your business is transparent on how the consumer data will be used, stored, and shared. You will need to be clear about how your contacts can opt out of your automated text messages as well as the types of messages they will receive and the frequency.

You need to show that you are protecting their privacy and adhering to proper SMS practices.

Here are some key parts of your privacy policy and terms of service.

- **No Third Party Data Sharing**: You will need to guarantee that that lead and client data will not be sold or shared to a third party.
- **Opt In Disclosure:** Provide clear steps on how your contacts will opt-in to text messaging.
- Opt Out: Provide clear steps on how your contacts will opt out of text messaging. Include that they will need to text back the keyword "STOP" to opt out.
- Data Collection and Usage: Details on how your contacts data is collected, stored, and used.
- **Message Frequency:** Indicate how often a contact can expect to receive messages from your business.
- Your Business Contact Information: While your contacts will have your contact info, your email and/or phone number will need to be stated if a contact needed to contact you regarding texting.

FAQs

I don't know how to build a webpage to add my Terms of Service and Privacy Policy on my site. What should I do?

We suggest creating your Terms of Service and Privacy Policy in a Google Doc. Then you can easily link to the READ ONLY link to your website.

Can I combine the Terms of Service and Privacy Policy into one webpage?

Yes. Make sure each one is clearly defined with a heading.

Where do the Terms of Service and Privacy Policy go?

They will need to be linked on your website. We recommend adding a link to the footer of your website.
