#### **USSS Competition License**

Every <u>skier and coach</u> participating at US Junior National Championships <u>must</u> have a current USSS Competition License. If you do not have one at the time the team is named, you must secure a competition license or a USSS Coaches License <u>immediately</u> from the USSS office in Park City, Utah. Call 435-649-9090 which is the US Skiing membership division office and ask for the membership department. You need to secure your license immediately.

PLEASE READ! <u>Skiers who are 18 or 19 during the season must be compliant with all Safe Sport regulations as described by US Ski and Snowboard to include completion of Safe Sport Online Training and completion of the Required Background Screening Process</u>. There are no exceptions to this requirement. It is not the responsibility of Intermountain USSS to facilitate the completion of this requirement. We recommend you call US Ski and Snowboard Member Services IMMEDIATELY with questions. ALL INTERMOUNTAIN COACHES attending Junior Nationals will have a USSS Coaches License including the completion of Safe Sport and other Licensing Requirements

Steve Vierk, US Ski Team Head Chef will be providing all dinners and non-race day hot lunches. For breakfasts and lunches, we will be keeping each of the houses stocked with food, including snacks. It will be up to the athletes to make their own breakfasts each day and lunches on race days.

#### Important - Read Carefully

You must agree to keep your rooms clean and orderly throughout the length of our stay. Keep the linens on the beds and the towels in the bathrooms. Please do not move furniture. If you break anything in your house, please be responsible and tell the coaching staff immediately. The cost of any damage to your room will be paid by you.

## **Trip Payments and Deadlines**

The cost of lodging, team dinners, waxing, championship entry fees and providing a support staff for a team of over 60 skiers and 15 staff is substantial. It is the goal of the team to provide our divisional skiers with the best possible Junior National experience. To this end, we are continually trying to balance the considerations of cost versus benefit. Each year, we do our best to secure safe and clean lodging, provide quality meals and put our skiers on fast skis. Listed below is a breakdown of the trip costs.

#### **IMD Team Uniforms:**

IMD athletes purchase their uniforms and jackets through the Podiumwear online storefront. <u>Jackets remain the same as in recent years. However, the race suit and Tech-T have a fresh new design.</u> Athletes are encouraged to purchase the new suit, but it is not required if they already have a suit from the previous

3 years. Uniforms are purchased via the online storefront and team headgear will be distributed to athletes when they arrive at Junior Nationals. Athletes may also borrow an IMD uniform from other athletes who are not attending. The team uniform that is available for purchase through the storefront includes the IMD Lycra race suit, IMD jacket, and the IMD short sleeve racing top (Tech-T).

#### **Team Responsibilities and Code of Conduct**

All team members must understand and accept that the task of coordinating and supervising a large group of athletes is entirely dependent on their cooperation. As members of the 2025 Intermountain Junior National Team, a requirement of your participation is that you agree to follow all team guidelines, rules and schedules. Please do not attend Junior Nationals if you cannot completely agree to this requirement. Specifically:

- You agree to follow all team schedules for daily training, team meetings and evening room curfews
- You agree to abstain from any use of alcohol, drugs or tobacco products throughout the length of the Junior National Trip
- You agree to treat your teammates with respect and abstain from all sexual relations throughout the length of the Junior National Trip
- You agree to treat your teammates, coaches, all race officials, volunteers, and fellow competitors with courtesy and respect at all times
- You agree to adhere to the stipulations of the Athlete Code of Conduct and Safe Sport Regulations as set forth in the USSS Cross Country Competition Guide
- You agree to abide by all of the behavioral standards set forth by the Intermountain Coaching Staff

Please understand that your failure to act in accordance with the above listed guidelines may result in disciplinary action that could result in your immediate dismissal from the Junior National Team and return to your home at **your expense with no refund of trip fees.**
