

Training radio-operator

Het CAMRAS bestuur wordt in de uitvoering van haar beleid in toenemende mate gehinderd door de oplopende meningsverschillen tussen een paar vrijwilligers. Om deze reden heeft het bestuur de instructie PI9CAM-operator, te geven door Jan, uitgesteld. Een open discussie is nodig (wellicht met een mediator) om dit verschil recht te trekken. Het CAMRAS bestuur heeft besloten geen geld uit algemene middelen te besteden voor deze discussie. The CAMRAS board sees growing difficulties in execution of her task due to some view point differences of a few volunteers. For this very reason, the board decided that the instruction session for PI9CAM operator must be postponed . An open discussion is required (probably with the aid of a mediator) to level out these differences. The CAMRAS board decided that this session will not be sponsored financially. Frans can assist in having a mediator available.
