Event:

A family friendly holiday fest and craft fair to raise funds for our school music program.
Performances by students in grades 6-12. Family members will be in attendance to watch.
As a crafter/vendor, please keep in mind the target audience of this event.
Raffles — Please consider donating a raffle item to help our programs.

Crafter/Vendor Space:

Space Size: Most crafter space size is **approximately** 8' x 7' (B hallway has a slightly different configuration).

Space Amenities: We **DO** provide one chair with each space. We **DO NOT** provide tables. (See registration form – we have a limited number of tables available for a small fee). We have very **limited** spaces with electricity (See registration form for details).

Space Location: All space locations are assigned **prior to** the event. We will make every effort to accommodate any space location requests as closely as possible, but this is **NOT** always possible. **NO** space requests are guaranteed.

Crafter/Vendor Fee:

Fee: \$60.00 for each crafter space. Additional spaces are \$60.00 each
Pre-Registration closes September 15, 2025. (Early bird pricing ends after this date).
After September 15, 2025, each crafter space price will be \$75.00.
You will be fully registered when we receive your payment and online registration.

NON-REFUNDABLE: All monies received will be **non-refundable** after October 1, 2025.
Cancellation requests **must be** received by email/letter prior to October 1, 2025.

Day of Event

Set Up: Doors open for set-up at **6:15am**. Doors open to the public at 9:00am. Go to the registration area first to check in. Vendors/crafters are responsible for carrying their own items. We will have a limited amount of "elf" helpers in the morning.

Crafter/Vendor Spaces: QMPO takes no responsibility for any items in any crafter/vendor space. Your table and items are **your** responsibility. Someone should be present at your table at all times during event operating hours, and no table should be left unoccupied at any time. "Elves" can stand at your table if you need a restroom break, but they may **not** be in charge of funds or make any transactions on your behalf.

Concessions: For your convenience, we will have volunteer "elves" that come around to take concession stand orders for you. We will also have pre-ordering prior to the event.

*Crafters/vendors are asked to **NOT** sell concession items from their tables. Only items wrapped and ready for sale should be sold by crafters/vendors. All vendors/crafters and the public are asked to visit the QMPO concession stand during the day.

End of Day: At breakdown, please make sure you clean up and leave your area free of debris as you found it. Crafters are asked to remove all personal belongings no later than 3:00pm.
