Log Files

Like many other Apps, com.LenPol.rippedabsworkout makes use of log files. This information is used to analyze trends, administer the app, track user's movement around the app, and gather demographic information. IP addresses, and other such information are not linked to any information that is personally identifiable.

Cookies and Web Beacons

com.LenPol.rippedabsworkout uses cookies to store information about visitors' preferences, to record user-specific information on which pages the app visitor accesses or visits, and to personalize or customize our web page content based upon visitors' browser type or other information that the visitor sends via their browser.
