It's an OVERLY thorough book detailing not only Parker's experiences but also a reprinting of Charles Hickson's account, several news reports, the official military reports, and a complete chronicle of everything Parker had to eat in the days leading up to and following the incident.

Sadly, he never saw fit to publish his fanfiction.

The Night in Question

Whichever version you want to go with, Charlie Hickson decided they had to tell the authorities about this. Calvin was dead set against it until it was decided he'd passed out and had nothing to tell. You know. Or whatever.

After a stop off at a bar for a single shot of Jack Daniels to calm his nerves, Charlie called the Air Force base but was informed "We don't handle that any more". They were, of course, referring to Project Blue Book which had already been shuttered. They told him to go to the Jackson County Sheriff's Department. So he did.

 You know somewhere, some Project Blue Book analyst was kicking themselves for letting the program get shut down when they heard about this story.

That shot would cost them right up front. Capt. Glen Ryder who just SOUNDS like an action star assumed they were drunk and lying so after questioning each man separately they left them in a room with a hidden tape recorder. He claimed further abduction and encounters for the rest of his life and discussed them extensively on the UFO convention circuit. He died in 2011.

He also wrote his own book called "PASCAGOULA - THE CLOSEST ENCOUNTER: MY STORY". While not well written it is EXTREMELY thorough and I recommend checking it out since it's thoughtful enough to include Charlie's story as well.
